A. Programme Rationale

The LLM is a popular stage in a student's study prior to the vocational stage of legal training or as a foundation for other career routes such as academia or business roles. It builds upon undergraduate academic study and allows students to explore the law in far greater depth than was possible for them at an undergraduate level. Our students include law graduates (both home and overseas), graduates from other disciplines, as well as lawyers already in practice. We offer both a one year fulltime and two-year part-time LLM in Law, (enabling studying alongside other commitments). However, the full-time option remains by far the most popular option with students. This year, we have introduced two 2-year full-time courses consisting of LLM (Sandwich) and



LLM with Work Experience in order to allow students to combine their interest in academic law with gaining valuable practical experience.

The LLM programme is designed to enable students to explore legal themes/concepts in depth, to inter-relate and evaluate them, and subsequently apply the law to complex problems and theories. Our LLM students are encouraged to be imaginative and to be ready to make creative, independent leaps in their research, (i.e. original thoughts). This approach is reinforced through rigorous research on the part of students to generate academically informed and commercially aware solutions/outcomes to complex problems. The goal of our LLM is to ensure that our students should not only be well qualified in independent research and complex problem solving but also equipped with a unique set of transferable, professional and research skills useful in their career and future employment.

The Hertfordshire Law School LLM offers a variety of specialisations and emphasizes the connections and interrelationships which may exist between the courses offered on the Masters Degree programme. The seven named courses consist of: Business Law, International Commercial Law and Arbitration, Intellectual Property and Information Law, International Human Rights Law, Criminal Justice, together with 2-year full-time courses of LLM (Sandwich) and LLM with Work Experience. This provides students with substantial flexibility in creating the programme of study which suits their particular needs/interests. The course specific module for each course ensures that students studying for a particular award are differentiated from students studying for any other award. Some courses also include a compulsory module of study that must be selected by students for that award (but which is also available as an optional module for other courses of study). They will also complete a dissertation/mini dissertation (if studying on Clinical Legal Education and Research Module) relating to one of their module choices. Students are then free to study optional modules alongside these course specific subjects and any compulsory modules.

B. Educational Aims of the Programme

In addition to all other modules, these two modules, in particular, develop and require students to formulate reasoned conclusions and propose new hypotheses and arguments.

Throughout, the learner is encouraged to develop transferable skills by maintaining a record of evidence and completing a personal development plan.

D. Programme Structures, Features, Levels, Modules, and Credits

The programme is offered in full-time (1 year and 2 years) and part-time (2 years) modes and leads to the award of a LLM Degree. Entry is normally at the Masters level (with related degree qualifications) Intake is normally Semester A (September) or Semester B (February).

Work-Based Learning, including Sandwich Programmes

LLM with Sandwich: Students must complete at least 30 weeks full time work experience. Students must normally pass all modules in the first attempt of their first semester (Semester A) to proceed onto the placement. For students with visa restrictions, the placement would need to take place within the UK. Students are not guaranteed a placement but will be encouraged to find their own and work with HLS Placement officer and UH Careers and Employment Service. The introduction to work placement module will support students in their search for a work placement and making applications. The Sandwich award requires completion of a full-time work placement (minimum duration: 30 weeks). It is assessed through reports while on placement (part of the 'Work Placement' module), and by portfolio in the module at the start of the final semester.

Students on the LLM Sandwich award who are aiming to progress onto the placement must meet the following progression requirements:

- No FRENs (Fail re-enrolment) are allowed from the 120 credits in Year 1;
- A maximum of 30 credits of FREF/DEF (Fail referred / deferred) modules are allowed.

Students on the Sandwich award who do not go on to a placement will transfer onto the Work Experience award route.

<u>LLM with Work Experience</u>: students who elect or transfer onto the work experience award will have to complete a 60 credit Work Experience module. This module includes compulsory elements including an introduction to the Law Clinic and commercial awareness. Students must complete 200 hours of work experience selected from a range of options. Student may also source their own work experience which must be approved by the School. It is assessed through reports while completing the work experience (part of the 'Work Experience' module), and by portfolio in the module at the start of the final semester.

For students on the LLM with Work Experience route:

- No more than 60 credits of FREN/FREF/DEF (Fail re-enrol/Fail referral/Deferral) modules are allowed from Year 1:
- No more than 30 credits of re-enrolled modules allowed in any one Semester in Year 2.

Programme Structure

The programme structure and progression information below (Table 1a and 1b) is provided for the award. Any interim awards are identified in Table 1b. The Programme Learning Outcomes detailed above are developed and assessed through the constituent modules. Table 2 identifies where each learning outcome is assessed.

If a student wishes to study for a named award, then they must study the Course Specific Module for that award together with any compulsory module indicated for that course. They may then choose modules from the list of options outlined below. The dissertation or mini dissertation topic (if they have been accepted to study on Clinical Legal Education and Research module) should relate to one of their chosen modules. Refer to Table 1a below for further details.

Alternatively, students are free to choose any combination of modules offered during Semesters A and B, (a maximum of two modules per Semester; four in total), except that they may not choose any Course Specific



Module. This leads to the award of an LLM in Law degree. Named PG Certificates and PG Diplomas are subject to the students completing the Course Specific Module and any compulsory module for that Award.

Intake is normally Semesters A (September) and B (January/February). Modules run only once per academic year. Therefore, a full-time 1-year Semester B intake student will start with the choice of semester B modules, followed by a Dissertation/Clinical Legal Education and Research module in Semester C, and finally finishing with a choice of semester A modules. In addition to the modules outlined below, all students (including students on the 2-year courses) must successfully complete either the Dissertation module or Clinical Legal Education and Research module, (which represent 60 credit points), in order to gain their LLM degree award. Please note that the Clinical Legal Education and Research module is an alternative Semester C (60 credit) module to the Dissertation module and will be available to limited number of applicants who will undergo a selection process over-seen by the Law Clinic Team. In addition, the LLM (Sandwich) 2-year full-time students must complete an Introduction to Work module (0 credits) in Semester B of the first year of study and a Work Placement Module together with a minimum of 30 weeks of work placement in Semester A/B of their second year of study. Similarly, 2-year full-time students selecting LLM with Work Experience must complete a Work Experience Module (60 credits), in addition to their work experience during their second year of study. For 2-year courses, the Dissertation module should be completed during Semester C of their second year of study.

7LAW2071 Research Methods and Skills is a compulsory zero-credit module which is intended to develop masters level skills in independent research and academic writing and this should be studied by all students in their first Semester of study. They must attend 60% of sessions.

Employability Skills and Career Planning (7LAW2001) is a zero-credit module which will be offered to students to help them to evaluate, develop and demonstrate their employability skills and attributes as they progress through their programme of study; and (2) explore and evaluate career routes and options in order to formulate, refine and implement a career development plan.

All students must study a zero-credit module Research Methods and Skills, which will capture the research skills being taught throughout the programme. To pass this module, students must normally attend a minimum of 60% of the sessions and will be assessed on a Pass/Fail basis. The module will be offered for both semester A and semester B entrants.

All students must study a zero-credit module Research methods and skills, which will capture the research and academic writing skills being taught throughout the programme. To pass this module, students must normally attend a minimum of 60% of the sessions and will be assessed on a Pass/Fail basis. The module will be offered for both semester A and semester B entrants. Students who have a disability which might impact upon their attendance should consult with their disability advisor.

The following staged progression requirements apply to this programme:

- 1. For students on the sandwich route:
 - *In order to enrol onto Year 2 (Sandwich), students need to have passed 60 credits in semester A. Students who haven't passed 60 credits in semester A are able to transfer to the work experience route.
 - Up to 30 credits of FREF/DEF are allowed.
- 2. For students on the Work Experience route:
 - No more than 60 credits of FREN/FREF/DEF are allowed from Year 1;
 - No more than 30 credits of re-enrolled modules allowed in any one Semester in Year

The normal entry requirements for the programme are:

Minimum of a lower second class degree in law or a related subject (such as Business, Political Science, Humanities, History, Technology or International Relations) or other appropriate qualifications and/or experience. Where applicants have a non-standard background, an admissions interview will be held with the Postgraduate Admissions Tutor against set criteria.

The non-standard applicants are expected to demonstrate the following in their interview:

- enthusiasm and motivation for the study of Law at a master's level
- evidence of wider reading or experiences that have motivated the applicant to apply to or prepared him for the course, including his views on current legal issues
- consideration of whether there are any aspects of the LLM of particular interest to the applicant, how it
 relates to their current academic programme and what additional reading or relevant experiences (e.g.
 attending court hearings) the applicant has had which have led him to commit to this challenging degree
 programme
- how their academic strengths relate to the programme and how di any extra-curricular activities benefit the applicant and could help him develop during this programme of study
- personal characteristics and skills that will be useful to students in their study of Law, including the ability to apply logic and follow complex lines of reasoning; ability to produce clear and concise argument; high levels of accuracy and attention to detail; good communication skills; the ability to ask questions and think independently; intellectual curiosity and the motivation and capacity for hard work.
- •Overseas equivalent qualifications welcomed. Minimum English Language requirement 6.5 IELTS with a minimum of 5.5 in each band.
