A. Programme Rationale

This Masters in Folklore Studies is the only such programme offered in England. It offers students with an Honours degree in a range of related subjects, such as History, English Literature, Anthropology, Archaeology, and Sociology, a thorough grounding in the history of the discipline of Folklore and current work in the field. This distinctive programme combines breadth with depth of study through wide-ranging but inter-connected modules with a focus on legend, ritual, belief, and tradition in British society. Students will also explore Folklore in comparative international contexts and consider its global importance as an aspect of UNESCO's definition of Intangible Cultural Heritage. The assignments allow student choice of topics, while the 15,000-word dissertation will give students the opportunity to specialise in researching their own area of interest under expert supervision. They will gain a series of transferable skills, including high-level research, multidisciplinary awareness, and presentation techniques, drawing upon the History Group's strengths in Heritage and public engagement. Graduates in Folklore Studies are equipped for a wide range of jobs, including careers in libraries, museums, tourism. arts organisations, the publishing industry, and funding agencies.

B. Educational Aims of the Programme

The programme has been devised in accordance with the University's graduate attributes of programmes of study as set out in UPR TL03.

Additionally this programme aims to:

- explore critical analyses and methods in Folklore Studies in a variety of temporal and geographical contexts;
- critically reflect on the relevance of Folklore Studies today as the origin and core of UNESCO's current emphasis on the global importance of Intangible Cultural Heritage;
- engage with current debates in the field of Folklore Studies at an advanced level;
- provide the structure for students to conceive, progress and deliver a substantial independent piece of research that offers an original contribution to knowledge;
- equip students with a range of general transferable skills which are of relevance to academic research and to a wide range of careers;
- provide students with a supportive, academic and pastoral environment in which to carry out their studies.

C. Intended Learning Outcomes

The programme provides opportunities for students to develop and demonstrate knowledge and understanding, skills and other attributes in the following areas. The programme outcomes are referenced the Frameworks for Higher Education Qualifications of UK Degree-Awarding Bodies (2014), and relate to the typical student.

G. Entry requirements

The normal entry requirements for the programme are:

• Masters (7) Level with a related degree qualification at 2:1 or above, but is also possible with a high 2:2 degree, via references and assessed writing.



- An Honours degree in Folklore Studies or a related discipline, such as History, Anthropology, Archaeology, Celtic Studies, and English Literature, with a minimum classification of second-class first division.
- IELTS requirement: 7 in all skills (Listening, Reading, Writing, Speaking).
