A. Programme Rationale

Postgraduate Design Programme - Overview

This programme addresses current and emergent trends in the Creative and Cultural Industries generally and in areas of Interior Architecture and Design, Graphic Design, and Illustration specifically.

This programme aims to give students an understanding of cutting-edge practice, develop their creative potential as a practitioner and give them the entrepreneurial skills they need to work successfully in their chosen specialist area of design.

PG Design includes:

Interior Architecture and Design explores a wide range of issues, including creative practice and space-making, as well as the use of materials, scales, and form in the creation of private, commercial, and public spaces. Working with a strong experimental ethos and developing solid technical skills, students examine the connection between architecture and interior design and the creation of both real and virtual spaces within an international, contemporary context.

Graphic Design and Branding adopts a creative, enquiring, and critical approach to the graphic image and its uses in contemporary practice. A wide variety of practices are supported, from traditional craft processes to contemporary digital image making. Students develop an individual professional practice informed by an awareness of the social, political, environmental, and commercial contexts of graphic design and the processes by which graphic signs operate to convey meanings in various environments.

Illustration allows students to develop their imaginative, creative, and technical potential through advanced knowledge and skills in the use of narrative storytelling and its relationship to illustration, as well as illustrative conventions in children's and adult literature, comics and other media. Students typically examine a range of media in the fields of illustration, including the role of image-making in new and traditional media and illustration's relationships with fine art and digital media.

Structure

At the heart of this is a learning and teaching methodology based around the idea of the enquiry, with the theoretically based common modules underpinning the practice-based modules. This concept structures our activities, promoting the transferable research skills characteristic of postgraduate education, enhancing critical



thinking and evaluation, requiring creative invention, analysis, and synthesis, and ensuring practice in a range of scenarios where communication of ideas and information takes place. There are full-time and part-time pathways, and all on-campus modules allow for student choice where learning is accessed online or on campus through hybrid delivery.

Career opportunities and distinctive features

Postgraduate Design aims to enable students to understand and operate within the complexity of our society and culture on a local and global scale. Sustainability, well-being, holistic design and their impact on the design industry are explored as recurrent themes in both theory and practice of design. The students are invited to adopt design methodologies that focus on the user experience, storytelling, and to acquire approaches of branding and design strategies according to the specificity of their subject. Through a combination of shared lectures, seminars, presentations, interdisciplinary projects and peer learning, students are encouraged to consider human-centred design from different viewpoints as collaborative opportunities between the three awards.

Students are encouraged to follow their aspirations whether to become freelancers or to join professional practices based on specific expertise or specialisms. From becoming experts in designing for well-being, sustainability, etc. to consultants in branding and communication, the programme offers the opportunity to understand the complexity of the professional world and facilitate the students to locate themselves within it.

B. Educational Aims of the Programme

Diversity and Inclusion

Our programmes are purposefully designed to enable all students to engage meaningfully with the curriculum by being accessible and representative. We will support students to shape their learning experience, removing barriers and enabling them to succeed. The curriculum explicitly includes multiple and representative perspectives, valuing collective identities and individual diversity. Learning, teaching and assessment activities help students to understand how they can enhance outcomes both for themselves and for others. All students belong to a learning community, and during their studies we really want to hear their voices, encourage them to listen to others, and express themselves.

- to provide a challenging environment which stimulates debate and fosters innovative and creative approaches to the subject;
- to provide students with a critically well-informed understanding of their chosen individual and discreetly differing disciplines at an advanced level;
- to provide students with a learning environment and intellectual framework which enables them to develop a conceptual and intellectual awareness of their chosen disciplines and current best practices at an advanced level.

Structure of Part-Time Postgraduate Design awards

Both on campus and online study modes share the same structure and, as far as possible, teaching. As far as possible part-time students are integrated with the full-time cohort as this brings many benefits of social learning and a sense of belonging to a community. Part-time students participate in lectures and activities together with full-time students for all the modules except Major Study Project which is mainly a student self-driven module.

Many part-time students also bring to their learning and to the programme relevant prior experiences, some of which may result in APEL.
