## A. Programme Rationale

This undergraduate programme is for students who wish to become Registered Nurses (RN) in one of the four fields of nursing; adult, child, mental health or learning disability. Registered nurses who graduate from this programme will be central in 'providing, leading and co-ordinating evidence based and person centred care' (NMC, 2018:p4). The programme will prepare students to practise in a wide array of health and social care arenas. The public and the profession expect registered nurses to act in a professional manner ensuring high standards of care (NMC, Code of Conduct, 2018). To meet these expectations our 'Future Nurses' (NMC, 2018) will value the diversity of their service users and carers in their care, whilst treating them with compassion, dignity and respect. Caring in a dynamic health and social care system will require our graduates to be accountable and able to act autonomously whilst working effectively in an interdisciplinary team.

Extensive partnership work has ensured that the programme has been co-produced with key stakeholders including service users, carers, students, academics and practice partners. This approach has led to a number of distinctive features:

- It is designed to encourage future practitioners to engage meaningfully with nursing research and evidence. It is guided by the four aspects of the Healy and Jenkins (2009) Research Informed Teaching perspectives in the teaching and learning outcomes, learning materials and proposed teaching and practice experiences. This scholarly approach will further the development of critical cognitive skills and other graduate attributes and facilitate on-going personal and professional development.
- Strength in the delivery of field specific modules and a diverse range of practice experiences whilst
  ensuring that the holistic care needs of all individuals encountered across the fields can be addressed.
- Programme delivery that reflects the views of service users and carers with meaningful input by them into a range of teaching and assessment activities.
- Authentic simulation activity that has been designed with service users, carers students and practice
  partner input.



The programme has been constructed to meet the NMC requirements as defined within the Standards Frameworks (NMC 2018, 2023). The programme has also been designed in line with the Framework for Higher Education Qualifications (QAA, 2008). The programme has been designed to include the <a href="Nursing Degree Apprenticeship Standard">Nursing Degree Apprenticeship Standard</a>.

## **B. Educational Aims of the Programme**

### **Diversity and Inclusion**

Our programmes are purposefully designed to enable all students to engage meaningfully with the curriculum by being accessible and representative. We will support students to shape their learning experience, removing barriers and enabling them to succeed. The curriculum explicitly includes multiple and representative perspectives, valuing collective identities and individual diversity. Learning, teaching and assessment activities help students to understand how they can enhance outcomes both for themselves and for others. All students belong to a learning community, and during their studies we really want to hear their voices, encourage them to listen to others, and express themselves.

The programme has been devised in accordance with the University's graduate attributes of programmes of study as set out in <u>UPR TL03</u>. The framework aims to provide a modular structure for the following programmes, each with its own programme specification:

- Enable students to contribute to and manage their own learning by effectively engaging with the evidence and research literature, reflecting on practice and continuing life-long learning.

### C. Intended Learning Outcomes

The programme outcomes are referenced to the Standards for Pre-Registration Nursing (NMC, 2018) and the Frameworks for Higher Education Qualifications of UK Degree-Awarding Bodies (2014) and relate to the typical student. Additionally, the SEEC Credit Level Descriptors for Further and Higher Education (2021) have been used as a guiding framework for curriculum design. The learning outcomes for the <a href="Nursing Degree Apprenticeship">Nursing Degree Apprenticeship</a> have been mapped against the learning outcomes.

The programme provides opportunities for students to develop and demonstrate knowledge and understanding, skills and other attributes in the following areas:

- A1- Effectively respond to legal, ethical, cultural and political issues impacting on current health needs and nursing practice.
- A2- Use critical reflective processes for continuing professional development.
- A3- Utilise personal/professional knowledge and skills from theory and practice to identify developing strengths and existing learning needs.
- A4- Effectively articulate the knowledge gained from a wide-range of theories, frameworks and disciplines with a critical appreciation of quantitative and qualitative research evidence and application to contemporary nursing practice.
- A5- Recognise the complex mental, physical, cognitive and behavioural care needs that can affect patients, service users and their carers.
- A6- Recognise the value of inter-professional education and the range of strategies that may be selected to enhance collaborative working.

## Teaching and learning methods

Acquisition of knowledge and understanding is based on knowledge construction and inquiry based learning.

To aid these modules focus on developing all four aspects of Healy and Jenkins (2009) research informed teaching.

Service user and carer involvement is integral to curriculum delivery as is interprofessional education. A combination of the following supports this: supervised and assessed practice experiences; simulated practice sessions; reflection; portfolio development; seminar and care pathway presentations; individual and small group academic tutorials; discussion groups, problemsolving and inquiry-led learning approaches; interactive lectures; coursework; learning packages; e-technology approaches to learning and teaching including, podcasts, video, and digital storyboards.

Throughout, the learner is encouraged to undertake independent study both to supplement and consolidate what is being taught/learnt and to broaden their individual knowledge and understanding of the subject. Additional support is provided by the Academic Skills team and Learning Resource Centre.

### Assessment strategy

Knowledge and understanding are assessed through a combination of assessments that are focussed on the knowledge and skills required for contemporary nursing practice. The assessments are designed to test the proficiency of the 'Future Nurse' utilising authentic and practice focussed assessments.

Activities involve critically evaluating research and evidence across the fields incorporating theory, practice, legislation and policy, research and leadership.

A range of formative and summative approaches are used including examinations in the form of multiple choice questions and scenario based short answer questions, assessed incourse assessments in the form of OSCEs, vivas, essays, project work, reflective accounts and presentations.

Practice forms 50% of the programme and assessment of practice forms a central tenet of this strategy. Assessment includes episodes of care, demonstration of professional values alongside a range of skills and attributes required for professional practice. Feedback on performance is obtained from registered nurses alongside other health and social care professionals. Service user and carer feedback is also integral to this.



### Intellectual skills

- B1- Understand and critically appraise research findings and best available evidence to promote health and deliver nursing care.
- B2- Analyse the nursing care needs of individuals and groups to find collaborative solutions which enable safe, effective, person and family-centred care.
- B3- Evaluate risk management strategies that promote a safe and therapeutic environment.
- B4- Analyse and appraise the evidence to find innovative research informed solutions that address problems and questions in practice.

Teaching and learning methods

Intellectual skills are developed throughout the programme by the methods and strategies outlined in section A, above. Analysis, problem solving and reflection skills are further developed by activities that encourage engagement with current research and evidence.

Students will critically discuss research with staff and peers. They will undertake active learning, through role-play, tutorials, simulation and practice placement experiences.

Throughout, the learner is encouraged to develop intellectual skills further by independent study.

Assessment strategy

As detailed in section A above, intellectual skills are assessed through a combination of formative and summative approaches including examinations in the form of multiple choice questions and scenario based short answer questions, assessed incourse assessments in the form of OSCEs, vivas, essays, project work, reflective accounts and presentations.

The final Imagination and Innovation module allows students to engage intellectually with innovation service delivery and change management.

Assessment in practice forms a central tenet of this strategy and includes episodes of care. demonstration of professional values alongside a range of skills and attributes required for professional practice. Feedback on performance is obtained from registered nurses alongside other health and social care professionals. Service user and carer feedback is also integral to this.

### Practical skills

- C1- Utilise information technology to effectively assist in the organisation and management of nursing care.
- C2- Systematically and comprehensively coordinate care by effectively assessing, planning, implementing and evaluating nursing care in partnership with patients, service users and/or carers.

Teaching and learning methods

Practical skills are developed throughout the programme by a combination of experience in the practice setting, simulated practice sessions and practice skills development, reflection sessions, seminar and scenario-based presentations, individual and small group tutorials, discussion groups, lectures, coursework and workshops, learning packages and computer assisted learning.

Skills learning is also facilitated by maintaining a Portfolio, which is a record of personal and

Practical skills are assessed in practice placements by means of achievement of modular learning outcomes for practice, contained in the Practice Assessment Document (PAD) This approach is complemented by other authentic assessments that relate to those skills required in practice e.g. simulation, audit; report writing, OSCEs, formulating service improvement developments.

Assessment in practice forms a central tenet of this strategy and includes episodes of care, demonstration of professional values alongside a range of skills and attributes required for professional practice. Feedback on performance is obtained from registered nurses alongside other health and social care professionals. Service user and carer feedback is also integral to this.

### Teaching and learning methods

Transferable skills are developed through the programme by interactive teaching sessions, practical computer assisted learning, debate, academic writing, practice experience and observation, oral and poster presentations and group/individual projects.

These are complemented by the development of specialist interprofessional transferable skills aided by two cross-School IPE modules.

### Assessment strategy

Transferable skills are assessed through a range of assignments built into the curriculum assessment strategy, in coursework, examinations, on-line \and computer based activities, oral presentations, reflective accounts and reports.

Assessment in practice forms a central tenet of this strategy and includes episodes of care, demonstration of professional values alongside a range of skills



D4- Demonstrate effective engagement and communication and collaboration skills with service users, carers and a wide-range of personnel from a variety of organisational levels.

Transferrable skills development is also facilitated by maintaining a portfolio, which is a record of personal and professional learning and development. Throughout, the learner is encouraged to develop transferable skills through self-reflection and on-going professional development.

## D. Programme Structures, Features, Levels, Modules, and Credits

The programme is offered in as a 3-year full time apprenticeship route. For applicants with an appropriate foundation degree, the length of the programme will be reduced dependent on the outcome of any Accreditation of Prior Learning (APL). All pathways lead to the award of a BSc (Hons) in Nursing. The programme is divided into three parts.

Intake is normally be in September.

Intakes for all fields for the shortened APL route with first registration will normally be in January.

The programme will normally be reduced in length (for students with a relevant foundation degree and or experience who successfully APL credits against the current programme outcomes using the APL process). The reduction in the length of the programme will be to a maximum of 50% of the programme. Entry for this route therefore will normally be at level five.

### **Professional and Statutory Regulatory Bodies**

All aspects of the programme are governed by the Nursing Midwifery Council professional regulations. Within the programme there is equal weighting between the delivery and assessment of theory and practice.

To meet the Nursing Midwifery Council regulations 4,600 programme hours are required for the full three year programme of which 2,300 are to be evidenced by practice experiences. Practice learning experiences are undertaken with a range of environments and students are supported by appropriately approved supervisors and assessors.

To complete all elements of the apprenticeship the apprentice must successfully complete an End Point assessment (EPA).

### **Table 1b Outline Programme Structure**

### APL/APCL&APEL and degree completion from foundation degree or equivalent.

It is anticipated that some students who completed prior learning to foundation degree level may wish to APL their prior learning. They will study a minimum of 50 % of the Nursing Degree. Sixty credits will be at level five where new learning specific to their chosen field of practice will be undertaken via a field specific practice module and a field specific 30 or 2 x 15 credit academic module. They will then follow the final level six components of the Nursing Degree.

### Mode of Study

Non-Registered Nurses-normally 20-24 months but determined by APL processes

## **Entry point**

Non-Registered Nurses normally semester B January intake to complete 60 credits at level five across two semesters. Modules as below. Then join the final year of the Nursing Degree to complete level 6 modules.

## Programme-specific assessment regulations

The programme complies with the University's academic regulations (in particular, <u>UPR AS11</u>, <u>UPR AS12</u> and <u>UPR AS14</u>) with the exception of those listed below, which have been approved by the University:

- Final compensatory credit (exemption from UPR AS14 section D4.4) and or inter-modular compensation is not permissible within the programme.
- Students awarded an FREN grade for 75 credits or more at a progression point will normally result in the student being withdrawn from their programme of study (exemption from UPR AS14 section D3). Where applicable, the employer will be informed of the failure to meet these requirements (normally, as part of the student's progress review).

Further programme-specific regulations (requiring School-level approval) are given below:

- Normally students cannot undertake further study at higher levels on the same programme of study if
  they have more than 30 credit points of failure outstanding from previous levels (Exemption from
  UPRAS14 D3.6) In these circumstances students may be able to undertake further study at a higher
  level on the same programme trailing up to 30 credits of module failure.
- Students will be expected to attend all theory and practice components of the programme without exemption. Failure to follow the attendance guidance, as per programme policy, will normally lead to withdrawal from the programme. Failure to fulfil the requirements for practice as per programme policy (including undertaking barring and enhanced disclosure checks, attending occupational health screening when referred and (where applicable) completing a statutory declaration will normally lead to the student being withdrawn from the programme. The employer will be informed of the failure to meet these requirements (normally, as part of the student's progress review).
- Failure to achieve a pass grade in relation to those attributes associated with professionalism within
  the practice document (as stated in the Professional Values Statement) in each year/part of the
  programme within EITHER the final summative practice experience of that part of the programme OR
  the subsequent retrieval practice experience will normally result in a student being withdrawn from
  their programme of study. The employer will be informed of the failure to meet these requirements
  (normally, as part of the student's progress review).
- Students must pass with 100% a health numeracy examination in their final year before the student may be recommended for entry to the professional nursing register.
- On completion of the programme, each student must submit a self-declaration of good health and character, as required by the NMC and which must be confirmed by a designated senior programme officer before the student may be recommended entry to the professional nursing register.
- All assessment outcomes must be completed and results confirmed at an examination board by the progression point normally at the end of each academic year or part of the programme.

## G. Entry requirements



The normal entry requirements for the programme are:

#### For All Routes

Evidence of completion of 12 years general school education before commencing the programme.


