A. Programme Rationale

The BA (Hons) Sociology has been designed to produce informed and active graduates, passionate about understanding and addressing the issues that shape 21st century societies. Following an activist, engaged approach to sociology, the degree equips graduates with the knowledge and skills to make a difference to local, national and global communities. The programme is structured to provide students with an in-depth and practically applied grasp of the theories, methods and subjects of sociological enquiry. Theoretical modules cover the history and development of social theory and encourage students to critically inquire how societies operate. Modules dedicated sociological investigation in practice build students' excitement for planning, undertaking and presenting their own research for a variety of professional settings.

The programme allows students to choose from a range of optional modules, including different languages, creating a flexible and personalised learning experience that reflects the interests and professional aims of every student.

In addition, students have the option to study Sociology as a joint degree with Psychology. The joint degree is designed to provide students with a thorough understanding in foundational areas of both sociological and psychological research and analysis. It particularly encourages students to explore synergy effects and cross-disciplinary connections between both subjects.

B. Educational Aims of the Programme

Diversity and Inclusion

Our programmes are purposefully designed to enable all students to engage meaningfully with the curriculum by being accessible and representative. We will support students to shape their learning experience, removing barriers and enabling them to succeed. The curriculum explicitly includes multiple and representative perspectives, valuing collective identities and individual diversity. Learning, teaching and



assessment activities help students to understand how they can enhance outcomes both for themselves and for others. All students belong to a learning community, and during their studies we really want to hear their voices, encourage them to listen to others, and express themselves.

The programme has been devised in accordance with the University's graduate attributes of programmes of study as set out in UPR TL03.

At all levels:

Acquisition of knowledge and understanding is through a combination of lectures and small-group seminars which are linked to self-directed and onlinedirected study before and after class. The seminars allow students to consolidate and apply knowledge and practice skills in different subject areas (A1-A7). (A1-A7). Modules at level 4 focus on building knowledge of important theories, concepts and lines and fields of investigation that characterise and distinguish sociological research (A1-A3).

At level 5:

Lectures and seminars introduce students to a range of theories, research strategies and research methods that allow them to explore social issues and processes in their complexity and prepare them for designing and conducting independent research (A4-A6).

At level 6:

Lectures and seminars familiarise students with the practice of social research, including methodological and ethical challenges (A7-A8).

Throughout, the learner is encouraged to undertake independent study both to supplement and consolidate what is being taught/learnt and to broaden their individual knowledge and understanding of the subject.

At all levels:

Intellectual skills are developed throughout the programme by the methods and strategies outlined above (B1-B8). Intellectual skills are being developed incrementally from level 4 to 6. At level 4, students will be provided with materials, directed to sources and confronted with specific tasks and problems of moderate complexity (B1-B3).

At level 5:

At level 5, the learner will receive direction but will be expected to plan their analysis and identify appropriate sources and methods of data collection and analysis independently (B4-B6).

At level 6:

The learner should be able to tackle complex issues and apply sociological theories and arguments in practice independently (B7, B8).

At all levels:

Intellectual skills are assessed through a flexible combination of different coursework tasks, such a critical reflections and research plans, and practical tasks including presentations and simulations (B1-B8).

At level 5:

B4-B6 are assessed by a variety of assessment methods which require the independent analysis of complex past or present social scenarios using a range of developed techniques relevant to the subject matter.

At level 6:

B7 and B8 are assessed in a variety of assignments that encourage students to apply their knowledge to social life and discuss political and ethical implications, specifically on the compulsory module "Making a Difference: Social Justice and Activism".

While all modules will encourage students to reflect on the situatedness of their own knowledge and analyses, this will particularly be required in the compulsory level 5 modules "Moving Stories: Migration, Society and Belonging" and "Doing Sociology: Preparation for Employability and Research" (C6-C7) and at level 6 in the compulsory module "Making a Difference: Social Justice and Activism".

The use of different methodological techniques and tools will be practiced in the compulsory module "Doing Sociology: Preparation for Employability and Research" and the optional module "Sociology at Work" at level 5, and in the compulsory module "Making a Difference: Social Justice and Activism" and the optional module "Sociology Dissertation" at level 6.

Assessment strategy At all levels:

Practical skills are assessed through a flexible combination of different coursework tasks, such a critical reflections and research plans, and practical tasks including presentations and simulations (C1-C8).

At levels 5 and 6:

Assessments at level 5 and 6 require students to critically reflect on the social, cultural and historical situatedness of their learning, research and research perspective and to independently use appropriate methodological techniques.

Entry is normally at Level 4 (with suitable A level or equivalent qualifications) but is possible at Level 5 and Level 6 with suitable accredited prior learning.

Intake is normally in Semester A.

At Level 4 students may choose to study 30 credits of a foreign language which replaces 30 credits of noncore compulsory modules from their main programmes. They may continue this pathway at levels 5 and 6. This study mode will not be reflected in their final degree title.

Work-Based Learning, including Sandwich Programmes

A sandwich award requires the successful completion of at least **30** weeks full-time equivalent placement activity from a maximum of two separate approved placements, neither of which will be normally less than **12** weeks in duration, in order for the award to be made. This is in addition to the period of academic study required for the full-time award. This optional placement year is undertaken after Level 5 and before Level 6 and meets the SEEC criteria for Level 6.

This optional placement year is undertaken after Level 5 and before Level 6 and meets the SEEC criteria for Level 6. This will usually be completed within the United Kingdom but, with prior approval, may be completed within other countries. Progress of the student's training and development is monitored through visits from University academic staff and/or through reports from the student. Students will be required to document this period of work in accordance with the guidelines produced by the School. Students on this study mode will be registered on The Humanities Placement Year module (6HUM1123).

Placements are advertised through the Career and Employment Office and have included areas such as marketing, journalism, PR, management and Policy Units. Students may also source their own placement, but it must be subsequently approved by the School in terms of health and safety, equality legislation and supervisory guidelines before a student can take it up.

All students are eligible to proceed to a placement year leading to the award ("with Work Placement") provided they have achieved 120 credits at Level 4 and at least 90 credits at Level 5 and have completed the appropriate placement induction and documentation. Success in the placement will be recognised in the title of the award but does not carry additional credit towards the Honours programme.

Students who have not achieved the minimum progression requirements at the end of Level 5 may be prevented from undertaking a sandwich placement. Students who are on the sandwich programme but have a 'Failed' grade in any Level 4 or Level 5 module will not normally be allowed to register to repeat this module until they return from placement.

Students may choose to combine completing a full Year Abroad followed by a sandwich placement, over 2 years, leading to the award of "with a Year Abroad (Sandwich)". Students on this study mode will be registered on the Study Abroad module (6HUM1049) followed by module The Humanities Placement Year (6HUM1123).

Student Exchange programme Incoming Exchange

Exchange students are permitted to study modules at all levels.

Study Abroad



All students on the course are eligible to complete a study abroad option, usually between levels five and six. Study abroad is normally one full year, but students can opt to complete one semester of study abroad and one semester of work experience, with the permission of the school.

Students wishing to study abroad at a host institution in another country, or to complete a work placement during their studies, may choose to undertake one of the following:

- The Humanities Placement Year (for a full year)
- Study Abroad (for a full year)

Combined Placement and Study Abroad Year

Students who are eligible for the Year Abroad or Placement Year will also be eligible for the combined Placement and Study Abroad Year. This will involve a semester spent in a partner university abroad that is willing to provide a study abroad semester, combined with an appropriate placement of a minimum of 12 weeks which can be taken either abroad or in the UK.

Placement with Study Abroad (for a full year)

Students choosing to undertake Sandwich, Year Abroad, Study Abroad will need to decide in advance of the following eligible academic year and discuss this with the Programme Leader and Student Record Administrator first.

Students normally progress to the next level of study in the academic year following any of the above.

A designated Year Abroad programme leads to a University award in Study Abroad mode and the words "with a Year Abroad" appear on the award certificate. The Year Abroad will provide students with the opportunity to expand, develop and apply the knowledge and skills gained at the start of their course in the School of Creative Arts (UH), within a different organisational and cultural environment in a partner academic institution. The host institution will appoint a Programme Co-ordinator who will oversee the student's programme during the Year Abroad and will liaise with the appointed UH Supervisor.

Students undertaking a full Year Abroad may undertake a period of study at an approved partner institution as <u>an additional year between Levels 5 and 6 (students must have passed 240 credits)</u>.

The year abroad comprises an agreed programme of study in the third year of a partner institution in Europe (other than the UK), North or South America, Australia or Singapore with which the University of Hertfordshire has an institutional agreement.

A student's programme of study will be negotiated and approved by the Dean of School (or nominee) in consultation with appropriate others and the host University. The programme provided by the host institution may comprise taught modules, a research project, field studies, or a mixture of these components. The programme of study will require a minimum of 25% of studies to be undertaken in aspects of culture of the placement country. Prior to the commencement of the year abroad, the student and Study Abroad Tutors from UH and the host institution will agree a learning contract. The learning contract will specify the assessment requirements to be met for successful completion of the programme of study. A Module Board of Examiners will consider the results for the year abroad during the first semester of the following academic year. All assessments must be completed by the end of the year abroad, and no subsequent referrals will be permitted. Students who have varied their programme of study without agreement from UH or have failed to meet the requirements of the learning contract will not have their year abroad studies included in the degree title

A student must confirm the intention to study abroad during the first ten weeks of study at Level 5. This will enable a place to be negotiated at a host institution and the Study Programme and learning contract to be arranged and agreed. Only a limited number of places exist. These will be awarded on the basis of the suitability of students and guided by choice on the most appropriate programme and host institution.



To be eligible to proceed to a year abroad, a student must, by the time of the Semester B Module Boards of Examiners, have achieved at least 210 credits overall, including at least 90 credits at Level 5. Success in the year abroad will be recognised in the title of the award but does not carry additional credit towards the Honours programme.

For the year abroad in Europe where study will be undertaken in a foreign language students must meet the host University's language requirements.

Alternatively, in exceptional cases where the curriculum provided at an approved franchise partner is aligned with that of their home programme and where this has been formally agreed by the Programme Leader, students may undertake this study period in place of Level 5 (Year 2) at the School of Creative Arts (UH). In this case, successful students will receive credit for 120 credits at Level 5 and their final degree classification will be calculated in line with those for a direct Level 6 entrant (i.e. Level 5 achievement/grades will not be taken into account).

Programme Structure

The programme structure and progression information below (Table 1a and 1b) is provided for the Honours award. Any interim awards are identified in Table 1b. The Programme Learning Outcomes detailed above are developed and assessed through the constituent modules. Table 2 identifies where each learning outcome is assessed.

^{*} In order to take 5EDU2027 *Sociology Dissertation*, students must normally have completed and passed *5EDU2022 Doing Sociology* at Level 5 and have a minimum average grade of 58 for Level 5 overall. Students who have a lower average for Level 5 normally need to take 120 credits of taught optional modules at Level 6.

The award of a BA Honours degree requires 360 credits passed with a minimum of 120 credits at Level 6.




