A. Programme Rationale

The programme is designed for those aiming for a career within an international business setting or roles requiring an understanding of International Business.

It covers various perspectives, including economics, marketing, entrepreneurship, sustainability, financial management, technology and HR. The programme will enable students to build a comprehensive understanding of a wide range of business-related disciplines and their interconnections.

Across the programme, students will develop essential skills such as effective communication in English, numeracy, multicultural teamwork, and an awareness of cultural, socio-economic, and political differences in business contexts. They will also adopt a reflective approach to learning, integrate information technology tools, and critically analyse complex business problems to find creative solutions. These skills are enriched by the development of a deeper knowledge and understanding of theories relating to international business.

In addition to a one-year full-time route, the programme also offers the opportunity for students to either undertake a work placement through an extended professional practice route or further develop their understanding of business environments through an applied business skills route.

For the MSc International Business with Extended Professional Practice, students will undertake an additional module in the first year titled 'Preparation for the Workplace.' This module is designed to prepare them for professional environments, enabling them to make informed decisions about suitable placement opportunities, and to apply effectively, thereby maximising their chances of securing an appropriate position. Students who secure a suitable placement and meet eligibility requirements will then spend an extended period applying their learned knowledge in a practical setting, gaining valuable industry experience. Upon completing their placement, they will return to complete their final Industry Research Project.

To qualify for a placement, students must have completed 120 credits and have passed the first 60 credits on their first attempt.

For the MSc International Business with Applied Business Skills, students will have the opportunity to undertake additional modules like business research skills and professional and consultancy skills. These modules will enable students to develop relevant research philosophical perspectives. Through case studies and real-life, practical international business problems, students will be prepared as individuals and as part of a cross-cultural project team, to design and implement different research methods in ethical and sustainable ways using emergent technologies. In addition, students will learn to communicate their research findings to a range of



audiences. Students will also develop professional and consultancy skills and be encouraged to apply professional, advisory and management principles to generate business solutions.

The Applied Business Skills pathway also includes a business simulation, allowing students to apply their theoretical knowledge and business research skills in a simulated real-world environment.

B. Educational Aims of the Programme

Diversity and Inclusion

Our programmes are purposefully designed to enable all students to engage meaningfully with the curriculum by being accessible and representative. We will support students to shape their learning experience, removing barriers and enabling them to succeed. The curriculum explicitly includes multiple and representative perspectives, valuing collective identities and individual diversity. - Prepare students to lead and collaborate effectively in multicultural and diverse teams, enhancing their capacity to manage and influence across cultural boundaries.
- Equip students with digital competencies, enabling them to analyse and leverage data, Al applications and digital marketing strategies to drive informed decision-making and innovation within the global business environments.
- Teach and integrate sustainability practices within all aspects of the curriculum to ensure students can

 business practices globally.

C. Intended Learning Outcomes

The programme provides opportunities for students to develop and demonstrate knowledge and understanding, skills and other attributes in the following areas. The programme outcomes are referenced the Frameworks for Higher Education Qualifications of UK Degree-Awarding Bodies (2024), and relate to the typical student. Additionally, the SEEC Credit Level Descriptors for Further and Higher Education (2021) have been used as a guiding framework for curriculum design.

Teaching/learning methods & strategies

Acquisition of knowledge and understanding is through a combination of lectures, small group seminars and tutorials, coursework including case studies, and supervised research work.

Throughout, the learner is encouraged to undertake independent study both to supplement and consolidate what is being taught/learnt and to broaden their individual knowledge and understanding of the subject (A1 – A7).

A8 is achieved through the fulltime, industry work placement experienced by students on the 'Professional Practice' award. Independent learning is supported by online Learning and Information Services resources, including guides to research materials produced specifically for this programme.

Assessment

Knowledge and understanding are assessed through a variety of in-course assessments including individual and group presentations, academic essays, business reports, and time-constrained assessments (A1-A7).

A8 is achieved through the full-time, industry work placement experienced by students on the 'Professional Practice' award.
To achieve A8, students on the Professional Practice

Teaching/learning methods & strategies

Transferable skills are developed through a combination of lectures, tutored group interactions and coursework - including group presentations and reports (D1-D3, D5) and individual reflective essays (D4, D5). The Business School's Academic Skills Unit supports this process, especially D1 and D3, through a combination of workshops, one-to-one meetings, and online briefings and tutorials

Throughout, the learner is encouraged to develop transferable skills by maintaining a record of evidence and completing a personal development plan.

Students on the Applied Business Skills award study 'Business Research Skills' and 'Professional Development and Consultancy Skills' in their second year, alongside the business simulation module. These two modules provide a strong grounding in workplace application of research and analysis, project management, and soft skills including leadership, teamwork, negotiation and creative problem solving.

Assessment

Transferable skills are assessed through a range of assignments built into the curriculum - coursework reports and oral presentations (D1), group work including the sharing of research findings (D2, D3, D5), individual reflective essays (D4, D5) and sustained pieces of informative and analytical writing for the Business Project. Applied Business project and Industry Research Project (D1, D3, D5).

For D6, 'Business Research Skills' and 'Professional and Consultancy Skills' require students to demonstrate knowledge in a variety of advanced research and skills areas through portfolio assessment and group work.

D. Programme Structures, Features, Levels, Modules, and Credits

The programme is offered in full-time one-year mode (1 year/17 months), and full-time, two-year modes, and leads to the award of an MSc degree International Business. Intake is normally available for Semester A (September) and Semester B (January/February). There are two, two-year full-time modes. The first one leads to the award of 'MSc International Business with Extended Professional Practice' and is only available to full-time students who join the programme during Semester A (September). The second two-year, full-time mode leads to the award of 'MSc International Business with Applied Business Skills' and is available to Semester A (September) and Semester B (January/February) intakes.

Entry is normally with an honours degree (at least 2:2 or equivalent) in any discipline, a degree equivalent professional qualification or appropriate work experience.

Work-Based Learning

The two-year, full-time Extended Professional Practice route incorporates a one-year work placement (minimum of 30 weeks) of full time work experience. Students must pass all modules in the first attempt of their first semester (Semester A) to proceed to placement.

For students on a Student Route visa, the placement typically needs to take place within the UK, as the visa covers you for placement based in the UK. However, if a non-UK placement meets the monitoring requirements set by the Student Immigration Compliance Team, then it may be considered. You are advised to contact SIT Compliance (sitcompliance@herts.ac.uk) for more information about this. Please be aware that if you take a placement outside the UK, the University cannot advise you on visa requirements to work in that country - it will be the sole responsibility of your employer to arrange the visa for you.

Students will typically need to secure a placement by the end of Semester B in their first academic year of study, in order to process the necessary paperwork required. The 'with Extended Professional Practice' award requires the completion of a full-time work placement (minimum duration: 30 weeks) which is assessed through milestone reports while on placement (part of the 'Professional Work Placement' module), and by portfolio in the 'Work Placement Portfolio' module at the start of the final semester. It is the responsibility of the student to identify and apply for placements, with support from the UH Careers and Employment Service, and the school's 'Preparation for the Workplace' module. Students on the 'with Extended Professional Practice' award who do not secure a placement will transfer to the two-year, full-time 'with Applied Business Skills' award route.

Programme Structure

The Programme Learning Outcomes detailed above are developed and assessed through the constituent modules. Table 2 identifies where each learning outcome is assessed.

This route of study incorporates a minimum of 30 weeks full time placement work. To undertake a placement, students must pass all modules in the first attempt of their first semester (Semester A). Students who are academically eligible for the 'with Extended Professional Practice route' would have to secure a Professional Work Placement by themselves with the support from the Careers and Employment Team. The Professional Work Placement would have to be approved by the Careers and Employment Team. Students who are not academically eligible, or not able to secure a placement, will be transferred from the 'with Extended Professional Practice route' to the two-year 'with Applied Business Skills' route. However, the change of study route may impact on students' degree award and eligibility for Graduate visa.

^{*} The Professional Work Placement period normally commences immediately after the end of Semester B (late May) in the academic year of starting the programme and ends at approximately the same time in the subsequent year. Placements are normally for a minimum of 30 weeks of full-time work. Immediately following the Work placement, students return, complete and submit their Work Placement Portfolio at the start of Semester C.

The award of an MSc International Business with Extended Professional Practice degree requires a total of 240 credit points at level 7. In addition, students are required to complete the 30-week full-time placement, submit acceptable milestone reports, and pass the Work Placement Portfolio at the start of their final semester.

The 'with Extended Professional Practice' route is not available for Semester B entrants.

The additional 60 credits of modules on the two-year full-time study route (Level 7 Business Research Skills and Professional and Consultancy Skills) are recorded on the transcript as pass/fail only, and no numeric grade will be awarded.

Programme-specific assessment regulations

The programme is compliant with the University's academic regulations (in particular, <u>UPR AS11</u>, <u>UPR AS12/UPR AS13</u> (delete as applicable) and <u>UPR AS14</u>) with the exception of those listed below, which have been specifically approved by the University:

Further points of clarification and interpretation relevant to this specific programme are given below:

- The two-year full-time 'with Extended Professional Practice' programme is only available to full-time, Semester A entrants.
- The award of an MSc International Business with Extended Professional Practice requires 240 credit points
 passed at Level 7, including placement modules 'Professional Work Placement' and 'Work Placement
 Portfolio' (following completion of a full-time 30-week minimum work placement). Students who do not
 successfully complete the placement and associated module assessments will be offered the award 'MSc
 International Business Studies', where the requirements of that award have been met.
- To progress to a placement, students on the 'with Extended Professional Practice' award must normally have completed 120 credits and have passed all 60 credits of the Semester A modules in the first attempt. Additionally, students undertaking a work placement can only trail up to 30 credits of referred (FREF) and/or deferred (DEF) modules from Year 1 and are not usually permitted any failures requiring re-enrolment (FREN) from Year 1. Students who have not met these progression requirements, including students with outstanding deferrals (DEF) from the first attempt at their first 60 credits, will be transferred from the 'with Extended Professional Practice' award to the two-year 'with Applied Business Skills' programme.
- Students are responsible for securing their own placement. Students are usually required to secure their placement by the end of April to process the necessary paperwork, allowing sufficient time to begin the placement and complete the 30* weeks of full-time work required. Students who do not secure a placement in this timescale will be transferred from the 'with Extended Professional Practice' award to the two-year 'with Applied Business Skills' award.
- The award of an MSc International Business with Applied Business Skills requires 240 credit points passed at Level 7, including the second year Business Research Skills and Professional and Consultancy Skills.
- The 'with Applied Business Skills' route is a stand-alone route and also an alternative route for students who were originally registered on the 'with Extended Professional Practice' route' but not academically eligible to progress to the Extended Professional Practice route or not able to secure a Professional Work Placement by the deadline given.
- To qualify for the 'with Applied Business Skills' award, students must successfully complete the 30-credit Level 7 modules 'Business Research Skills' and 'Professional and Consultancy Skills'. Students who do not successfully complete these modules will be offered the award 'MSc International Business studies', where the requirements of that award have been met.
- The award calculation for 'MSc International Business with Applied Business Skills' will be based on an average of the best 150 of 180 grade-bearing credits on the programme; the remaining 60 credits gained from 'Business Research Skills' and 'Professional and Consultancy Skills' are excluded from this calculation, as these modules are graded pass/fail (and feature as such on the award transcript).
- Students cannot progress to their Year 2 Applied Business Skills route with more than 60 credits of failed (FREF/DEF/FREN) modules in Year 1. Students are permitted to progress to the second year of the Applied Business Skills programme with trailing failure modules and may only repeat a maximum of 30 credits in Semester A and 30 credits in Semester B, in year 2. All students undertaking a two-year Applied Business Skills programme of study will be automatically re-registered on any failed modules from Year 1.
- Students on the standard, one-year pathway and the "with Applied Business Skills" pathway can only enrol on either 7BUS2217 (Business Project) or 7BUS2213 (Applied Business Project).
