At its meeting on Tuesday, October 20, 2020 with the Honorable Chuck Smith, Chairman present; the Honorable Sandy Haskell, Vice Chairman present, and the Honorable Danny Feagin present; the Judicial and Public Safety Committee took the following actions:

1. Removal From the Table the Proposed Second Reading of an Ordinance (1) Repealing All Of the Sections In Chapter 4, Animals and Fowl, Of the Aiken County Code Of Ordinances, (2) Replacing Those Existing Sections With New Sections On Definitions; Animal Control; Impoundment, Redemption and Adoption; Dangerous Animals; Rabies Control; Identification; Running At Large; Creating a Public Nuisance; Abuse, Neglect and Abandonment; Tethering Dogs; Enforcement; Penalties; and Related Matters, and (3) Revising the Organization of the Articles and Sections In Chapter 4.
