#### WHEREAS:

- 1. Aiken County's continuing efforts to address the critical issues of safety, energy efficiency, and resilience in the built environment that affect our citizens, both in everyday life and in times of natural disaster, give us confidence that our structures are safe and sound; and
- 2. Our confidence is achieved through the devotion of vigilant guardians building safety and fire prevention officials, architects, engineers, builders, tradespeople, laborers and others in the construction industry who work year-round to ensure the safe construction of buildings; and
- 3. These guardians dedicated members of the International Code Council use a governmental consensus process that brings together local, state and federal officials with expertise in the built environment to create and implement the highest-quality codes to protect Americans in the buildings where we live, learn, work, worship, play; and
- 4. The International Codes, the most widely adopted building safety, energy and fire prevention codes in the nation, are used by most US cities, counties and states; these modern building codes also include safeguards to protect the public from natural disasters such as hurricanes, snowstorms, tornados, wildland fires and earthquakes; and
- 5. Building Safety Month is sponsored by the International Code Council, to remind the public about the critical role of our communities' largely unknown guardians of public safety our local code officials who assure us of safe, efficient and livable buildings; and
- 6. **"Safer Buildings, Safer Communities, Safer World,"** the theme for Building Safety Month 2020, encourages all Americans to raise awareness of the importance of building safe and resilient construction; fire prevention; disaster mitigation, backyard safety; energy efficiency and new technologies in the construction industry. Building Safety Month 2020 encourages appropriate steps everyone can take to ensure the safety of our built environment, and recognizes that the implementation of safety codes by local and state agencies has saved lives and protected homes and businesses, and;
- 7. Each year, in observance of Building Safety Month, Americans are asked to consider projects to improve building safety and sustainability at home and in the community, and to acknowledge the essential service provided to all of us by local and state building departments, fire prevention bureaus and federal agencies in protecting lives and property.





# Mapette of Proposed Rezoning









- 3. AEC will reimburse Aiken County for all costs involved in conducting the election, including personnel, advertising, printing, supplies and any other direct or indirect costs in connection with the election; and
- 4. The terms and conditions of this arrangement will be fully set forth in a separate agreement between the Commission and AEC; and
- 5. County Council desires to allow the Commission to enter into this agreement and provide this service to AEC.

#### NOW THEREFORE BE IT RESOLVED BY THE AIKEN COUNTY COUNCIL THAT:

- 1. The Aiken County Registration and Elections Commission ("Commission") is hereby authorized to execute an agreement between the Commission and Aiken Electric Cooperative ("AEC") for the Commission's assistance in conducting a trustee election for AEC.
- 2. This approval is contingent upon review and approval of the agreement by the County Attorney.
