Enhancing action on adaptation in Africa

CONTEXT

Climate change is one of the most urgent threats for the African continent. Its negative impacts are already being felt across Africa and the landscape is changing as a result. Reduced agricultural production and food security, increased sea level rise, frequent droughts, and floods: these are just some of the pressing issues affecting already vulnerable communities in Africa.

In response, the Committee of African Head of States on Climate Change (CAHOSCC) established a new initiative to enhance action for climate adaptation. The **Africa Adaptation Initiative (AAI)** was formally launched at COP 21, in Paris, in December 2015, by the President of the Republic of Egypt, **H.E. Abdel Fattah El-Sisi**.

In 2016, a Technical Working Group (TWG) was established to guide the AAI's development and operationalization. The TWG is chaired by AMCEN and comprises representatives of the African Group of Negotiators (AGN), the African Union Commission (AUC), the African Development Bank (AfDB), NEPAD's Planning Coordinating Agency (NPCA), the United Nations Economic Commission for Africa (UNECA), the United Nations Development Agency (UNDP), the United Nations Environment Programme (UNEP) and the African Risk Capacity (ARC).

The Government of the Republic of Gabon – as current chair of CAHOSCC and the AU's "Champion" of the AAI – made a first and significant financial contribution to the AAI at the end of 2017. The goal is to support the implementation of the AAI, focusing on the four pillars of the initiative, but most importantly to help encourage mobilization of additional resources for full implementation.

As part of these efforts, the African Union, the Government of the Gabonese Republic and UNDP are jointly hosting a **High-Level Partners Roundtable in New York, on the margins of the UN General Assembly on the 24th September 2018, 10:30-11:30am**, in order to mobilize resources for the full implementation of the AAI.

OBJECTIVES

The aim of the **High-Level Partners Roundtable** is as follows:

- **Sensitising and raising awareness on climate adaptation in Africa:**
 - A **detailed discussion paper** will be launched, previewing key messages from the first **Africa State of Adaptation (SoAR) Report** (to be published by the AAI at COP 24, in December 2018).
- **Operationalising the AAI**
 - A resource mobilisation process will be launched, seeking US\$5m for the operationalisation of the AAI and US\$30m for its Flagship Programmes.
- **Mobilising partners for the implementation of flagship adaptation programmes:**
 - Presentation and launching the AAI's flagship programmes.

THE AFRICA ADAPTATION INITIATIVE

The AAI leverages support and expertise to significantly scale up climate adaptation on the African continent. The AAI's framework document, outlining the targets and activities in each of four pillars, was launched in November 2016 at COP 22 in Marrakech. A work plan outlining the planned activities was approved by the TWG at a meeting held in Libreville, May 2017.

The four pillars of the AAI's mandate are:

- Enhancing climate information services to support decision-making;
- Strengthening policies and institutions;
- Enhancing on-the-ground action; and
- Mobilizing climate finance and investment.

The AAI will collaborate with existing institutions and organisations that are implementing initiatives and programmes on the continent that address adaptation and build long-term resilience.

The AAI will also:

- Raise awareness about the importance of climate adaptation in Africa;
- Facilitate capacity building and capacity strengthening of African actors through training and research;
- Facilitate the scaling up of initiatives and programmes on the continent, by mobilising resources for their implementation;
- Facilitate partnerships among organisations working on the continent to scale up, replicate and implement new initiatives and activities; and
- Measure progress of adaptation action through monitoring and evaluation of adaptation action.
