

## **GISD Alliance Second Annual Meeting (virtual) Wednesday, 14 October 2020, UN HQ New York**

### **Draft Agenda (as of 6 October 2020)**

The dramatic impact of the COVID-19 outbreak has lifted the world off its hinges since the UN Secretary-General launched the Global Investors for Sustainable Development (GISD) Alliance in October 2019. Significant gaps in the implementation of the Sustainable Development Goals (SDGs) have been exposed and exacerbated further by the pandemic. Additional challenges emanating from other global risks, including climate change and social injustice, were pushed into the spotlight.

An Extraordinary Meeting on “COVID-19: Response and Recovery” between GISD Members and the Secretary-General, held on 10 June 2020, stressed the sense of urgency and led to a re-orientation of the GISD work programme. The GISD Alliance Members agreed to renew, recharge and reinforce their efforts to scale sustainable finance for the timely achievement of the SDGs. To transform this commitment into concrete action, the Second Annual Meeting of the GISD Alliance will have the following objectives:

- i) Identify deliverables for the GISD Alliance and ensure commitment from GISD Members to their implementation;
- ii) Engage with Member States on the realization of the GISD Alliance deliverables;
- iii) Raise global awareness for the work of the GISD Alliance through media outreach.
