PRESTIGE marechal saldanha

Foz, Oporto - Portugal

Concluded in 2022, Prestige Marechal Saldanha is located in Foz, on the iconic Rua do Marechal Saldanha.

Designed by Miguel Nogueira, from NN Arquitetura, the building houses 6 premium residential apartaments of different types and areas between 122 sqm and 240 sqm.

Standing in a glamorous location, near the most trendy restaurantes and stores, this development was entirely sold during construction, with prices targeted at top tier level.

With a total gross building area above ground of 1.524 sqm, Prestige Marechal Saldanha represented a global investment of €4.000.000.

Chiado, Lisbon - Portugal

Developed by Aliança Atlântica Ativos, SICAFI, SA, Alure is located in the historic heart of the city of Lisbon, on the iconic Rua do Alecrim, in an exceptional and imposing urban situation.

Designed by architect Samuel Torres Carvalho, the developed program reconverts a typically Pombaline building dedicated to services and commerce into a residential unit with 14 apartments, of different types and areas between 88 sqm and 204 sqm, as well as 4 commercial units. Larger units offer semi-automated parking in the building itself.

With a total gross building area above ground of 3.294 sqm, Alure represents a global investment of over €14.000.000.

Ribeira, Porto - Portugal

Alfândega 80 is located at Rua Nova da Alfândega, in the heart of the historic center of Porto, adjacent to the Ribeira (Material Heritage of Humanity) and on the first line of the river.

The project developed for this building by the Anarchlab studio proposes, for this distinguished building from the beginning of the 20th century, the creation of 6 residential units of 1 bedroom and 2 bedrooms (this one with parking), with areas between 57 sqm and 185 sqm, as well as a commercial unit.

With a total construction area above ground of 763 sqm, Alfândega 80 represents a global investment of around €3.200.000.

mutua Campo Alegre Workplace

Campo Alegre, Porto - Portugal

Developed in partnership with Osborne+CO, this building is located at the intersection of two important streets in the city, Rua do Campo Alegre and Rua Gonçalo Sampaio, the prime office area in Porto, Boavista CBD, the MUTUAL building, former Ageas headquarters. With ESG placed at the heart of the proposed intervention, the building will be refurbished to create around 10,000 sqm of cutting-edge Grade A office accommodation, addressing the health and wellness needs of the modern workplace. It represents a global investment of €35.000.000.

Vacharest, Bucharest - Romania

Located in Bucharest, Green Cascade benefits from the proximity to Vacharest Nature Reserve Park. To take advantage of the surroundings and seek a harmonious integration, instead of a traditional block, the proposal developed by the architectural firm StudioAct, stacks all the ingredients of a lively urban neighborhood connected by a continuous internal garden. The project aims to create a three-dimensional urban neighborhood where suburban life merges with the energy of a city. The project has approximately 60.000 sqm of construction area





intended for residential use.







São Paulo and Minas Gerais, Brazil

Quartzo is a real estate developer founded in 2011 in Brazil based in Belo Horizonte, State of Minas Gerais. The company has a strong presence in this capital and its metropolitan region, but is also present in the region called Triângulo Mineiro and metropolitan regions of São Paulo and Campinas. Initially focused on projects eligible for the state program to promote construction and housing for lower-income families, the "Programa Minha Casa, Minha Vida", now called "Casa Verde e Amarela", the company has been diversifying its market, keeping part of its projects within the "Casa Verde e Amarela" program and developing others within the scope of the Brazilian Savings and Loan System (higher ticket units, intended for the middle class segment). By 2024, Quartzo had delivered more than 3.000 housing units and has 500 units under construction.
