## FINANCING AGREEMENT

### ON THE ONE HAND

**URBANITAE INMOBILIARIA PLATFORM, S.L.**, a company incorporated in Spain, with tax identification number B-88.393.962 and registered office at Calle Castelló, 23, first floor, 28001, Madrid (hereinafter, the "**Platform**");

### ON THE OTHER HAND

The user registered on the Platform's website as an investor (hereinafter, the "**Investor**" or the "**Lender**");

### ON THE OTHER HAND

**IRIS S.R.L.** a limited liability company incorporated under the laws of Italy, with its registered office in Milan, via Carlo Matteucci 2, Tax Code: 04022210126, represented by Mr Zhabko Denis, born in Aktubinsk (Kazakhstan) on 26 December 1980 in its capacity as sole director duly authorized according to the by-laws of the company (hereinafter, the "**SPV**").

Collectively, the Platform, the Investor and the SPV shall be referred to as **the "Parties"**.

The Parties acknowledge that they have sufficient legal capacity to enter into this framework agreement (the "**Agreement**"), as well as the specific terms set out in **Annex I** (*Specific Terms of the Loans*) of this Agreement (the "**Specific Terms**") and, to that end,

## NOW THEREFORE

- I. That the Platform, authorised as a provider of participatory financing services by the National Securities Market Commission, registration number 2023045268 and authorised under licence number 4, is a company that connects a limited number of users, known as investors (natural or legal persons) who offer funding in exchange for a financial return, with users who apply for funding in their own name to allocate it to a crowdfunding project for a residential development, known as developers. That the Platform is a "*crowdfunding platform*" within the meaning of Article 2 of Regulation (EU) 2020/1503 of the European Parliament and of the Council of 7 October 2020 on European crowdfunding service providers for businesses, and amending Regulation (EU) 2017/1129 and Directive (EU) 2019/1937 (the "**Regulation (EU) 2020/1503**").
- II. That the SPV is a limited liability company (*società a responsabilità limitata*) incorporated under the laws of Italy, the corporate purpose of which is, inter alia, the purchase, sale, exchange, construction, reconstruction and renovation of immovable property, as well as the management and letting of property owned by the SPV "codice Ateco 41"
- III. That the Platform has presented to users registered on its website a proposal under which the Investor, together with other investors (collectively referred to as the "**Investors**"), may provide financing (directly or indirectly) to the SPV, on the principal terms and conditions set out in **Annex I** (*Specific Terms of the Loans*) of this Agreement, for the acquisition and development project consisting in the partial financing of a residential development comprising 24 newly built units (the "**Development**") located in Via M. Borroni 2, Busto Arsizio, Italy (the "**Asset**"), the principal terms and conditions of which are attached to this Agreement as **Annex II** (the "**Project**").
- IV. That the Investor has expressed to the Platform its interest in participating in the Project by providing financing to the SPV in the form of a loan, on the principal terms and conditions set out in **Annex I** (*Specific Terms of the Loans*) of this Agreement, for the purpose of financing the proper development and execution of the Project (the "**Loan Agreement**", the "**Loan**" and, together with those of the other Investors, the "**Loans**"), resulting in a potential return for the Investor through the payment of interest and the repayment of the Loans; accordingly, the Investor grants the Platform a mandate to act on its behalf and in its name on

the terms set out below, without the Platform acting as an Investor or developer in relation thereto.

## PROVISIONS

### 0. PRE-CONTRACTUAL COOLING-OFF PERIOD

As set out in Article 22 of Regulation (EU) 2020/1503, the Investor, if considered a retail investor, shall have a period of four calendar days, starting from the moment of the investment offer or the expression of interest on their part in the Project. During this period, they may withdraw their investment offer or expression of interest in the crowdfunding offer at any time, without having to justify their decision and without incurring any penalty.

To exercise this right, the Investor must send an email [to\\_contacto@urbanitae.com](mailto:to_contacto@urbanitae.com) within a maximum of four calendar days from the time they made their investment. In any case, the Platform reserves the right to close the project or to reach the initial investment target with new investors.

### 1. PURPOSE

The purpose of this Agreement is to regulate: (i) the terms and conditions applicable to the Loans as granted by the Investor through the Platform in favour of the SPV; (ii) the relations between the Parties, as well as the relations between the Investors in their capacity as lenders to the SPV; (iii) the principles governing the SPV's actions in relation to the Project; and (iv) the rules to which the management of the SPV must adhere through its relevant Governing Bodies, as defined below.

### 2. COMMITTED CONTRIBUTION

The Platform shall publish on its website the total aggregate amount required for the Loan, which is to be used for the proper development and implementation of the Project (the "**Funding Target**"), for the purpose of publicising it to potential investors. For the purposes of this Agreement, the term "**Committed Contribution**" by the Investor shall mean the specific amount that the Investor authorises and commits, via the Platform, to finance the Project, thereby contributing to the achievement of the Funding Target.

Once the Funding Target has been reached within the timeframe established for the Project and, in any event, once the pre-contractual cooling-off period mentioned in the previous paragraph has elapsed, the Investor shall be informed that their contribution will be transferred to the SPV and to an account held by it by way of a Loan, which shall in all cases be governed by the terms and conditions set out, inter alia, in this Agreement.

To this end, by signing this Agreement, the Investor grants the Platform an irrevocable mandate to carry out the following actions on their behalf and for their account, once the Funding Target has been reached:

- (i) the corresponding transfer to the SPV by way of a Loan for the amount of the Committed Contribution, once the security and guarantees provided under this Agreement have been created, which shall take place in the order of priority to be agreed by the Parties;
- (ii) the formalisation, in the name and on behalf of the Investor, of the Loan Agreement to be signed with the SPV, which shall be formalised in a private document, as well as the administration of the collections and payments arising from said Loan Agreement, under the terms and for the amount determined by the Investor via the Platform, as well as the performance of the intermediary functions necessary for these purposes; and
- (iii) the execution of any public and private document that may be necessary, convenient or appropriate for the purposes of (i) the proper granting, execution and documentation of the Loan, as well as (ii) to enforce the security and guarantee linked to the Loan Agreement in the event of default of the SPV's failure to comply with its obligations in accordance with the terms of this

Agreement, the Loan Agreement and the other financial documents (including (a) the possible assignment, by the Investors, of their contractual position in the Loan Agreement (or other financial documents) in favour of a third party previously determined by the Platform, or (b) the Platform's intervention in its own name and on behalf of the Investors to carry out or entrust to a third party any action relating to the claim for any payment, or the creation, enforcement or execution of any security and/or guarantee relating to the Loan. In this regard, the Investor undertakes to provide any documentation the Platform may require for this purpose.

The Funding Target shall be made available to the SPV and shall be used exclusively to finance the Project, as well as to cover the expenses provided for in this Agreement, in accordance with the details described in the Project published by the Platform on its website.

### **3. APPOINTMENT OF THE MANAGEMENT BODY**

The SPV's management body takes the form of a sole director, a position held by Mr Zhabko Denis. The management body is hereinafter referred to as the "**Management Body**".

### **4. EXPENDITURE POLICY**

Pursuant to the Funding Target, the Investor authorises the SPV to proceed with the construction and marketing of the Development at the price and subject to the restrictions described on the Platform's website.

Furthermore, the following expenses shall be borne by the SPV and charged to the Funding Target: notary and legal fees (the latter up to a cap of Euro 11,800), land registry fees and any other expenses directly related to the drafting, negotiation, execution and formalisation of the Loan Agreement and other financial documents, including the creation of the relevant security and guarantees.

### **5. PROHIBITION ON DISTRIBUTIONS BY THE SPV**

The SPV undertakes not to make any distributions to its quotaholders, affiliates, members and related parties until the irrevocable and unconditional discharge in full of its obligations under the Loan Agreement and the other financial documents, as well as not to incur any financial indebtedness in addition to that arising from the Loan as long as the principal and interest of the Loan have not been repaid irrevocably and unconditionally in full under the specific terms and conditions set out in this Agreement, in the Loan Agreement and in the other Financial Documents, except in those cases where the additional financial indebtedness is intended to repay the interest and principal on the Loan or in other specific cases that may be provided for in the Loan Agreement.

### **6. PRINCIPLES OF ACTION OF THE SPV**

The SPV undertakes to the Investors that the Funding Target shall be used exclusively for the purpose set out in this Agreement.

### **7. INVESTOR REPORTING OBLIGATIONS**

The Platform undertakes to provide the Investor with information relating to their investment via the Platform's website, without prejudice to other disclosure obligations that must be complied with under applicable legislation.

Furthermore, the Platform, as part of its obligations under Article 23(8) of Regulation (EU) 2020/1503, shall immediately inform the Investor of any material change to the information provided to them in relation to the Project, whether on the Platform's website or in this Agreement.

For these purposes, a material change to the information shall be understood as one which, without impacting the Project's profitability, provided it does not undermine its viability or entail a change detrimental to the Investor, affects the control structure of the companies involved in the Project, even where such modification entails a

change to the Funding Target communicated to the Investor.

To this end, the Platform reserves the right to make, on behalf of the Investor, the structural changes necessary to the Project in order to optimise it, and must report any changes in the space created for each Investor of the Project on the Platform's website, providing a Project monitoring document explaining how the transaction will ultimately be structured.

## 8. POWER OF ACTION OF THE SPV'S MANAGEMENT BODY

The Parties agree that the SPV's Management Body, unless the Investors have given their prior consent (in the manner set out in clause 17 "**General Provisions**"), may under no circumstances take any of the following actions: (i) approval of additional expenditure charged to the Funding Target other than that provided for in this Agreement; (ii) the acquisition of shares not provided for in this Agreement; (iii) the adoption of any resolution that may prejudice, hinder or prevent the irrevocable and unconditional repayment in full of the Loan; (iv) the transfer, in whole or in part, of the Asset (in any form, including the sale of a going concern, demerger, merger, contribution in kind and any other transaction with a similar effect); (v) the adoption of any agreement that may prejudice, hinder or prevent the proper creation, establishment or enforcement of the security and/or guarantees to be created in connection with the Loan Agreement; and (vi) the transfer in whatever form of the Asset in a way prejudicial to the interests of the Investor under the Loan Agreement.

## 9. REPRESENTATIONS AND WARRANTIES IN RELATION TO THE SPV

SPV is an Italian company, duly incorporated under Italian law, with its registered office in Milan, via Carlo Matteucci 2, Tax Code: 04022210126. The deed of incorporation of the SPV was executed on 13 May 2024, before Notary Dr Enrico Maria Sironi, under ref. no. 23949, file no. 13716.

Furthermore, the SPV declares that under no circumstances shall it bear any expenses, costs or damages arising from activities other than those provided for in Clause 4 pursuant to the Funding Target.

SPV, on its own as well as on behalf of its quotaholder, hereby represents and warrants that, to the best of its knowledge, the SPV and its quotaholder have fulfilled so far and are correctly fulfilling all their obligations arising from the agreements to which they are parties (hereinafter the "**Agreements**") including, without limitation, (i) the deed of transfer of quotas dated 26 June 2025 (ii) the deed of pledge over Iris S.r.l.'s corporate capital dated 26 June 2025. To this regard, the entering into this Agreement and, more in general, the draw down of the Loan as well as the granting of the Security, as defined below, does not (x) require the prior approval, in whatsoever form, by any other party nor (y) purport the termination, cancellation or voidability or, in any case, the loss of effectiveness of the Agreements.

## 10. GRANTING OF LOANS TO THE SPV. GENERAL TERMS AND CONDITIONS

### 10.1. Loan

The Committed Contribution intended for the granting of the Loan to the SPV shall be governed by the terms and conditions set out in this Agreement and in the Specific Terms attached to this Agreement as **Annex I** (*Specific Terms of the Loans*).

The Loan granted by the Investor is a **financing product**, the return on which depends exclusively on the SPV's ability, as borrower, to fulfil its obligation to repay the accrued interest and the principal of the Loan in a timely manner.

For information purposes only, it is expressly stated that the granting of the Loan by the Investor entails assuming a risk of (i) total or partial loss of the Committed Contribution; and (ii) failure to obtain the expected financial return.



The Investor acknowledges that extraordinary circumstances not foreseen in the Project (including, but not limited to: a fall in property market prices, a decline in demand, an increase in construction costs, delays in administrative procedures for obtaining permits or licences, etc.) may cause the future financial return to be delayed or to be less than their Committed Contribution, assuming, in their capacity as lender, the risk associated with the execution of the Project.

The granting of the Loan shall be formalised through the SPV by the Investor, represented by the Platform in accordance with the irrevocable mandate granted in Clause 2 above, in a private document.

#### **10.2. Use and purpose of the loan**

The SPV undertakes to allocate the funds received from the Loan solely and exclusively as set out in this Agreement and, in particular, in accordance with the provisions of Clause 6 above.

The Loan may be disbursed following the fulfilment (or waiver by the Platform) of all conditions precedent to the use of the Loan, and therefore, from the date of utilisation of the Loan, the SPV shall be obliged to repay the amounts owed as principal, to pay interest, fees, taxes and accrued expenses, as well as to comply with the other commitments and obligations for which it is responsible in accordance with the terms and conditions set out in this Agreement, the Loan Agreement and the other financial documents.

The SPV undertakes to adopt, within its relevant governing bodies, prior to the signing of the Loan Agreement and the granting of the Loans in its favour, such decisions and resolutions as may be necessary to fulfil the Funding Target.

#### **10.3. Accrual of interest. Interest period.**

The SPV undertakes to pay interest on the Loan to the Investor at the interest rate set out in the Specific Terms.

The outstanding principal of the Loan at any given time shall accrue daily interest in favour of the Investor at the applicable interest rate set out in the Specific Terms.

Interest shall be deemed to accrue on the basis of a year of three hundred and sixty (360) days and shall be calculated for the days actually elapsed during the Interest Period, as defined below (at the end of which the first day of the Interest Period shall, in any event, be deemed to have actually elapsed and the last day not to have actually elapsed).

"**Interest Period**" means the period from (and including) the date of disbursement of the Loan up to (but excluding) the next date on which interest is due, as better specified in the Specific Terms.

The duration of the Interest Period shall coincide with the duration of the Loan, as specified in the Specific Terms, and therefore there shall be a single interest or settlement period, which shall commence on the date on which the Loan has been disbursed in accordance with the provisions of Clause 10.2 above.

Interest accrued during the single Interest Period shall be payable by the SPV on the due date of the Interest Period, coinciding with the Loan maturity date, and must be paid within a maximum of ten days of such due date. The Platform shall distribute among the Investors the amounts paid by the SPV in respect of the Loan (principal and interest), paying each Investor the proportionate share due to them, net of any tax deductions where legally applicable.

No capitalisation or compounding shall be permitted in relation to the Loan.

It remains understood that, in case the interest rate on the Loan exceeds the usury threshold rate from time to time applicable in Italy as provided for by Law no. 108 of 7 March 1996 (as amended and supplemented) and the related

issued decrees of the Ministry of Treasury of Italy, the applicable rate of interest payable by the SPV shall be the maximum rate permitted by Law no. 108 of 7 March 1996 (as amended and supplemented) and the related issued decrees of the Ministry of Treasury of Italy.

#### **10.4. Majority of Investors**

Decisions by the Investors under the Loan Agreement shall be taken, unless expressly provided otherwise therein, by a majority of the Investors, and any decision so taken shall be binding on each and every one of them.

“**Majority of Investors**” means all Investors whose share of the outstanding Loans amount represents, at any time, more than fifty per cent (50%) of that figure.

For the above purposes, the Platform shall inform the Investors of the decisions to be submitted for their consideration, which shall be deemed accepted by each Investor unless they express their opposition in writing within 15 calendar days. Any decision taken in relation to the Loan Agreement and other financial documents provided to Investors shall be deemed to require the agreement of the Majority of Investors, unless otherwise stated.

For information purposes, the acceleration of the Loan, the enforcement of the security or securities, or the novation of the Loan Agreement shall be subject to the decision of the Majority of Investors.

#### **10.5. Mandatory ordinary repayment**

The SPV must repay the Loan in full and all amounts owed to the Investor under this Agreement, the Loan Agreement and the other financial documents on the Loan maturity date specified in the Specific Terms. Furthermore, after any transfer, in whole or in part, of the Real Estate Units of the Asset (in whatsoever modality, including sale of going concern, demerger, merger, contribution in kind and any other transaction having a similar effect), regardless of when it takes place, shall entail the obligation of the Borrower to allocate all funds obtained from such sales, net of taxes and expenses associated with such sale, to the repayment of the Loan (the “Net Proceeds”). Accordingly, the Net Proceeds obtained by the SPV from the sale of any of the Real Estate Units shall be paid by the purchaser immediately and directly, following the completion of such sale, to the Investor on a current account indicated by such Investor.

#### **10.6. Voluntary early redemption**

The SPV, at its own discretion, may decide to repay the full amount of the Loan in advance, regardless of whether or not this coincides with the end of the Interest Period, provided that the Platform is given at least twenty (20) calendar days’ prior notice. The early repayment shall include, together with the principal of the Loan, all interest and other costs and expenses accrued up to the date of early repayment, which, if repaid before the 12th month following the disbursement of the Loan, shall in any event include the amount of interest accrued during that period. The SPV shall not be obliged to pay any fee for early repayment.

#### **10.7. General Rules**

The SPV’s obligation to make payments to the Investor shall be deemed to have been fulfilled when the SPV has sufficient funds to cover its payment obligation in the virtual account held by the SPV on the Platform, and actually does so.

The SPV is obliged to make and settle any withholding tax on capital gains required by applicable tax legislation at any time.

Payments arising from the Loan, whether in respect of principal, interest or expenses, shall be made (i) on the due date of the Loan or in accordance with the provisions of this Agreement for early repayment thereof, or (ii) at

the time they are due from the Investor in accordance with the provisions of this Agreement, by debiting these amounts from the relevant account held in the Platform's name, without the need for a prior payment order. The SPV undertakes to maintain sufficient funds in this account to cover the aforementioned payments.

The amounts received by the Investor as payment shall be applied first to the reimbursement of expenses and taxes, secondly to late payment interest, thirdly to ordinary interest and, to the extent that they exceed this, to the outstanding principal.

#### **10.8. Default interest**

In the event of any delay that may occur, whether in the payment of the principal or in the payment of interest and expenses payable by the SPV, default interest shall accrue daily in favour of the Investors at the rate specified in the Specific Terms, without the need for notice, from the day following the due date or the date on which the unpaid amount becomes due and payable until full payment is made.

Default interest shall be paid in a single instalment, together with the payment of the interest due or the principal of the Loan, as the case may be, or, failing that, on the Loan's maturity date or upon the declaration of acceleration of the Loan.

It remains understood that, in case the default interest rate on the Loan exceeds the usury threshold rate from time to time applicable in Italy as provided for by Law no. 108 of 7 March 1996 (as amended and supplemented) and the related issued decrees of the Ministry of Treasury of Italy, the applicable rate of interest payable by the SPV shall be the maximum rate permitted by Law no. 108 of 7 March 1996 (as amended and supplemented) and the related issued decrees of the Ministry of Treasury of Italy.


#### **10.9. Joint and separate nature of each investor's Loan**

The contractual position assumed by each Investor vis-à-vis the SPV in relation to their respective Loan is joint and several, and therefore the Investor's rights and obligations are independent of those of the other Investors, unless expressly provided otherwise in this Agreement and subject to the majority rule set out in the Loan Agreement, where applicable.

#### **10.10 Obligations of the**

In relation to the Loan, the SPV undertakes to:

- Repay the principal of the Loan and settle all other amounts for which it is liable for any reason (ordinary interest, default payment interest, fees and Platform expenses of any kind) on the dates and under the conditions agreed in the Specific Terms.
- The SPV undertakes to provide the Platform with the information or documentation requested by the Platform regarding its financial situation, within a maximum period of fifteen (15) days from the request and, specifically, to provide documentary evidence that it is up to date with the payment of its respective tax obligations, social security contributions and payments to its employees.
- The SPV undertakes to use the entire amount of the Loan for the purpose described in the Loan application and in this Agreement, the Loan Agreement and the other financial documents.
- To carry out and cooperate in all necessary actions to obtain, extend or renew any authorisation required for the proper fulfilment of the obligations arising from this Agreement.
- The SPV acknowledges and authorises the persons designated by the Platform to carry out all physical or documentary checks to verify the details mentioned above and to provide the requested supporting documents.



Unless expressly authorised by the investors, until the full repayment of any amount due under the Loan Agreement and the other financial documents, the SPV undertakes (i) not to incur any financial debt other than that arising from the Committed Investment which is not intended for the implementation of the Project; (ii) not to grant loans or guarantees in favour of third parties unless consented under the Loan Agreement; (iii) not to create any form of guarantee, pledge or any other type of security, charge or encumbrance of a similar nature over its assets in favour of third-party creditors other than the Investors; (iv) not to participate, directly or indirectly, in subsequent projects other than the Project; and (v) not to make distributions to its shareholders, affiliates or related parties.

The disclosure obligations and authorisation to carry out documentary checks provided for in this clause for the SPV shall also apply to any guarantor, security provider, surety or, in general, any guarantor of the Loan.

#### 10.11 Loan Guarantees

The SPV is liable for the full and timely performance of the obligations assumed under this Agreement and the Loan Agreement (the "**Secured Obligations**") with all its assets, present and future.

Furthermore, and without prejudice to the foregoing, the SPV shall provide the following security, to be provided around the date of execution of the Loan Agreement and as condition to the disbursement of the Loan ("**Security**"), in order to secure the full and timely performance of the Secured Obligations assumed by the SPV under the terms set out in this Agreement:

- First ranking mortgage on the assets of Iris S.r.l.
- First-ranking pledge over all present and future bank accounts of the Borrower, including all credit balances and proceeds thereon. It remains understood that the pledge will be enforced only in case of Borrower's gross breach to the loan agreement .
- Cost overrun guarantee from the Borrower, covering any shortfall in the total development costs required to complete the Project.
- Full cash sweep
- Maintenance of the Guarantees during the life of the loan and impossibility of granting the same or better guarantees in favour of other creditors.
- Subordination of corporate loans as well as of any other loan to the Urbanitae loan.
- Irrevocable Mandate of Sale in favour of the Lender enabling the direct sale of the underlying asset of the project from a price floor equivalent to 75% of the last available appraised value on the effective date of the Mandate of Sale. The effective date of the Sale Mandate shall be called during the last 6 months of maturity. The details of the sale mandate will be further clarified and agreed upon by the parties as the transaction progresses to a more advanced stage

The Security will be interconnected with each other and form a single guarantee package and the maximum guaranteed amount of each and all the Security shall be equivalent to 130% of the principal amount of the debt.

#### 10.12 Assignment of loans

The Investor may assign the Loan Agreement and/or all or part of its rights under the Loan Agreement, subject to prior notification to the SPV. The assignment shall automatically result in the assignee stepping into the assignor's rights, both in relation to this Agreement and in any other contract, if any, relating to the financing of the Project. Notwithstanding the foregoing, the validity of the assignment shall be subject to the registration of the new creditor on the Platform.

In such a case, the Security granted in relation to the Loan shall remain in force and continue to have full effect.

- The SPV has breached the terms of any loan or credit agreement to which it is a party (including those not arranged through the Platform) and, furthermore, the SPV has been required to make an early repayment in the event of default or the Platform has reasonable grounds to believe that, as a result of this: (i) the SPV may also imminently breach the terms of this Agreement, or (ii) any of the grounds for termination of this Agreement set out in this Clause may arise;
- In the event that all or part of the security/guarantee linked to the Loan is declared invalid or unenforceable by a court judgment and the SPV has not provided the Platform with a satisfactory and sufficient alternative security to fully replace the potentially unenforceable or invalid security or guarantee within fifteen (15) days of the Platform's reasonable request.
- In the event of a breach of the representations and warranties given by the SPV under this Agreement.
- Any other termination provided for in the Loan Agreement.
- The Asset is transferred in a way prejudicial to the interests of the Investor.

#### 14. LEGAL CLAIM

In the event of a breach of the payment obligations arising from this Agreement and the consequent early termination thereof, the Platform may transfer, in the name and on behalf of each of the Investors, the Investors' contractual position in the Loans to a third party, whether a natural or legal person, including for the purpose of enforcing the security or guarantees linked to the Loan or claiming the corresponding debt through the filing of legal proceedings arising from this Agreement. To this end, the Platform may refer the legal claim to the debt collection agency with which it has reached an agreement for the recovery of the outstanding payments linked to the Loan.

The Platform may also, in its own name and on behalf of the Investors, take or entrust to a third party the taking of the necessary steps for the judicial or extrajudicial recovery of any payment arising from the Loan, including the creation or enforcement of any security interest, including the Pledged Securities.

#### 15. NOTIFICATIONS

The Parties agree to the electronic formalisation of the Loan and to the sending of any notifications to the email address [contacto@urbanitae.com](mailto:contacto@urbanitae.com); accordingly, the provisions of Law 34/2002 of 11 July on information society services and electronic commerce, and Law 22/2007 of 11 July on the distance marketing of financial services to consumers.

It is the responsibility of the SPV to reliably communicate any changes to the contact details provided, and until such changes are correctly communicated to the Platform, the details currently available shall be valid for the purposes of any notification relating to this Agreement.

#### 16. VALIDITY OF THE CONTRACT AND CONDITION PRECEDENT

This Agreement shall be effective in respect of all Parties on the date of its acceptance, subject to the condition precedent set out below (the "**Condition Precedent**"):

This Agreement shall come into force when the Funding Target is reached within the specified timeframe. At that time, the Platform shall inform each of the Parties, for this purpose, of their Committed Contribution and the

### 10.13 Remedy for investors

If, for any reason, the SPV fails to repay the Loan or pay the interest or expenses set out in the terms and conditions of this Agreement, the Loan Agreement and the other financial documents, the Investor shall in all cases bear the risk of default and acknowledges that they may make a claim against the SPV's assets.

## 11. INFORMATION REGARDING PAYMENTS AND RISKS ASSOCIATED WITH TRANSACTIONS

All payment transactions arising from the activities and operations under this Agreement shall be channeled through a payment institution, with each Party opening a payment account for this purpose, all in accordance with the terms and conditions set out by the Platform on its website.

The Investor declares that they have read and understood the risks associated with the transaction and the investment described on the Platform's website and, in particular, declares that they are aware of the risk of total or partial loss of the capital invested as a Loan, the risk of not obtaining the expected financial return, as well as the risk of a lack of liquidity to recover the investment.

## 12. FEES AND EXPENSES

The following fees shall be payable to the Platform and shall be borne exclusively by the SPV:

- **Project fee:** Once the Funding Target has been achieved, the SPV must pay the Platform the project fee specified in the Specific Terms, which is calculated on the basis of the Funding Target, plus the applicable Value Added Tax. The loan project fee will be deducted before the funds are made available to the SPV.

- Any other expenses and taxes arising from the performance of this Agreement, as well as from the creation (registration and cancellation where applicable), modification and enforcement of the security interests, including the payment of stamp duty, even in the event that the SPV is not the taxpayer liable for such duty.
- Costs of valuing the asset.
- Administrative costs for the processing of the agreement and the registration/cancellation, where applicable, of the security interests.

## 13. GROUNDS FOR TERMINATION

The SPV agrees that the Platform may, on behalf of the Investor, terminate this Agreement and request full reimbursement of the amounts due in connection therewith, if:

- The SPV fails to make a payment or makes only a partial payment of an amount due under this Agreement;
- The SPV provides false information, including cases where this has affected the decision to allow the Investor to register as a member of the Platform and publish the Project application on the Platform, or has affected the credit rating that the Platform has assigned to the SPV;
- The SPV or any of its security providers, if any: (i) fail to comply with their financial reporting obligations or fail to file, whilst legally obliged to do so, their annual accounts with the relevant Companies Register; (ii) are

## 17. GENERAL PROVISIONS

Such amendments shall be deemed to have been accepted by the Investor if they do not express their objection in writing within 15 calendar days.

Any other amendment to this Agreement requires the express agreement of all Parties.

The costs and taxes arising from the execution and performance of this Agreement and the transactions provided for therein, including the creation, amendment, cancellation and eventual enforcement of the security/guarantee linked to the Loan, shall be borne by the SPV.

The Platform, the SPV and the Investors may not assign the rights and obligations arising from the Agreement, unless otherwise provided for in this document.

For any matter not provided for in this Agreement, the provisions of the General Terms and Conditions available on the website [www.urbanitae.com](http://www.urbanitae.com) shall apply to the Investor, which the Investor has declared to be aware of and to understand and accepts in their entirety.

The Parties consent to the electronic execution of this Agreement and the sending of any notification to the email address [contacto@urbanitae.com](mailto:contacto@urbanitae.com), all in accordance with the regulations applicable for these purposes.

## 18. COMPLAINTS

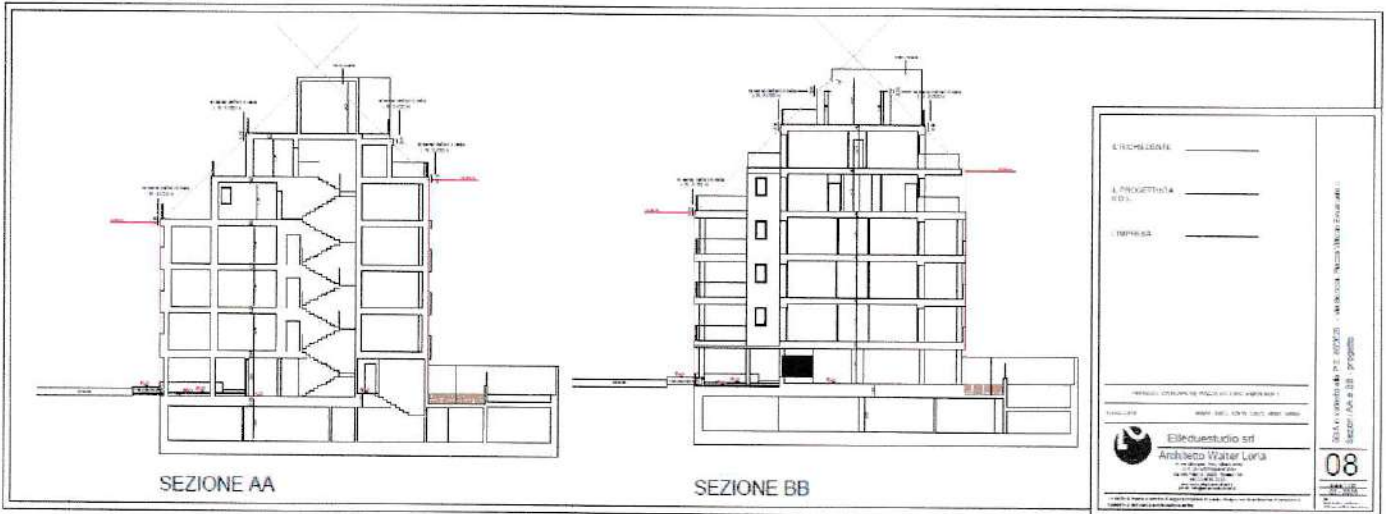

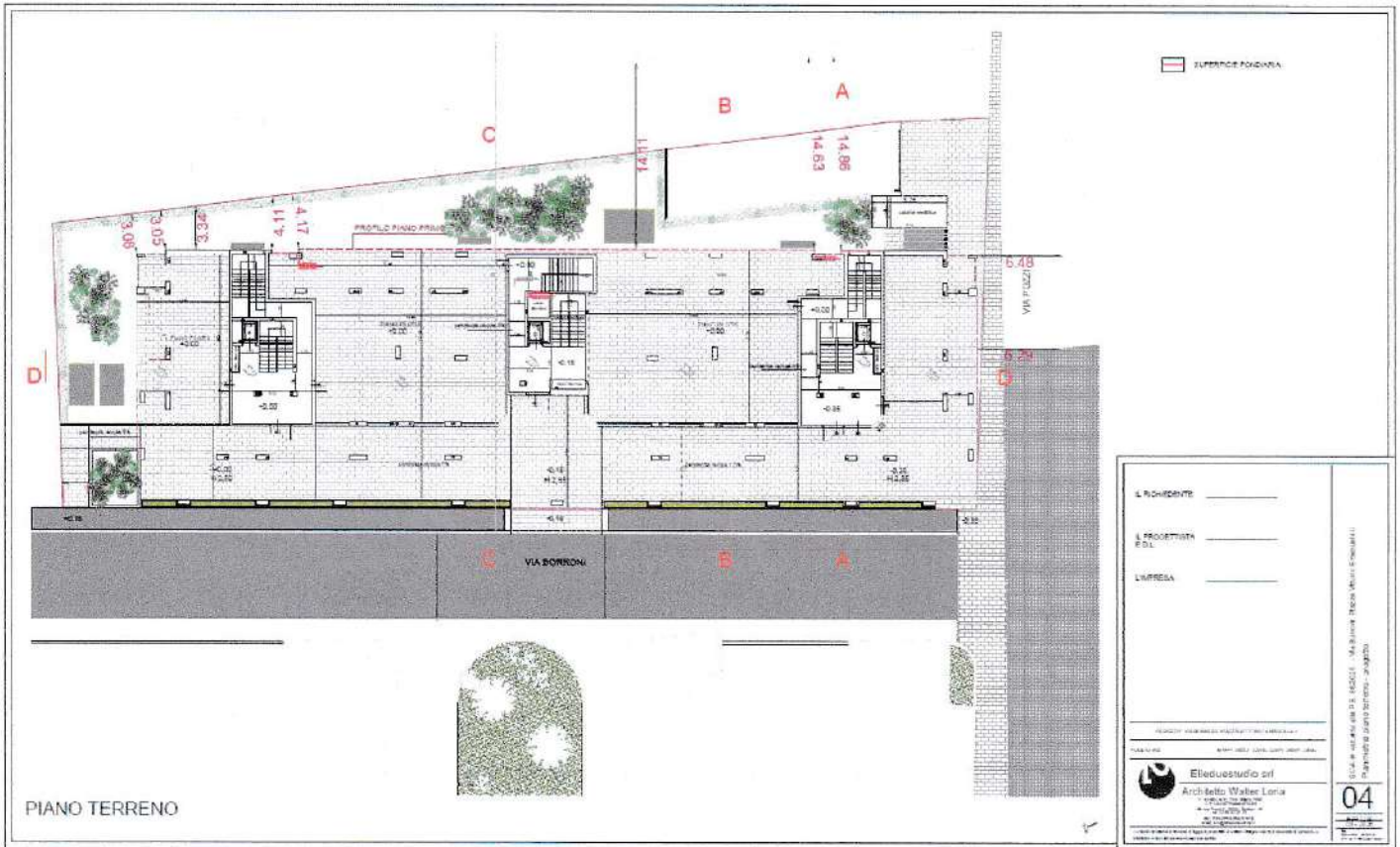

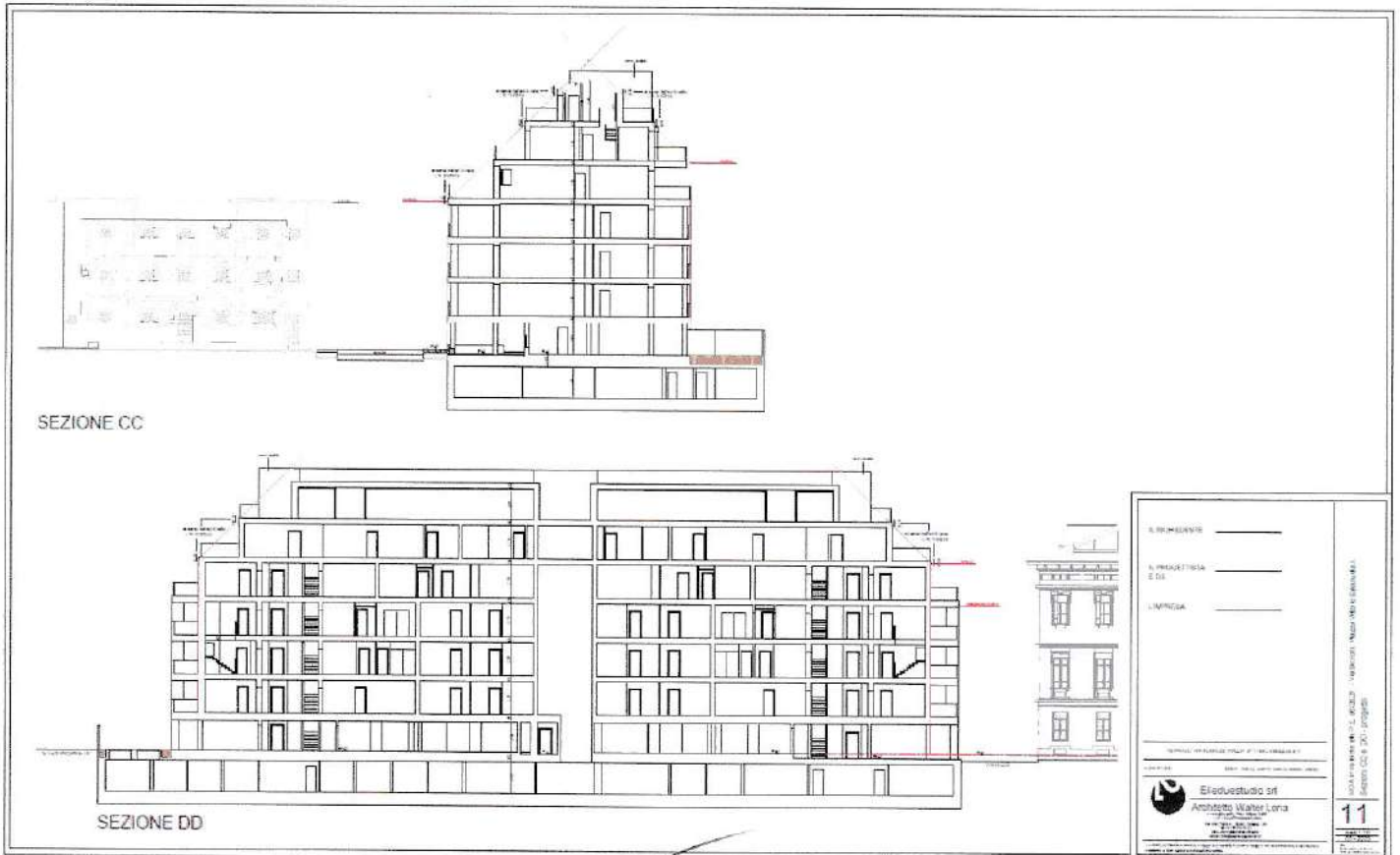

**ANNEX III**  
**INDIRECT MANDATE AGREEMENT IN FAVOUR OF THE AGENT**

**On the one hand,**

Each of the users registered on the website of URBANITAE REAL ESTATE PLATFORM, S.L., in their capacity as investors in the Loan defined below (the "Investors" or the "Principals");

**On the other hand**

URBANITAE REAL ESTATE PLATFORM, S.L. (the "**Platform**" or "**Urbanitae**");

**And, furthermore,**

**PROPTECH SERVICIOS GENERALES, S.L.**, a Spanish company, with Tax Identification Number B-13.857.610 and registered office at Calle Castelló, number 23, 1st floor, Madrid (the "**Agent**").

Hereinafter, the Investor, the Platform and the Agent shall be referred to collectively as the "**Parties**" and individually, where applicable, as a "**Party**".

The Parties acknowledge that they have sufficient capacity to enter into this indirect mandate agreement (the "**Mandate Agreement**" or the "**Agreement**") and, to that end,

**HEREBY DECLARE**

- I. That the Platform, authorised as a crowdfunding service provider by the Spanish National Securities Market Commission, registration number 2023045268, and authorised under licence number 4, is a company that connects a limited number of users, known as investors (natural or legal persons) who offer funding in exchange for a financial return, with users who apply for funding in their own name to allocate it to a crowdfunding project for a residential development, known as developers.
- II. That the Platform is a "*crowdfunding platform*" within the meaning of Article 2 of Regulation (EU) 2020/1503 of the European Parliament and of the Council of 7 October 2020 on European business crowdfunding service providers, and amending Regulation (EU) 2017/1129 and Directive (EU) 2019/1937 (the "Regulation (EU) 2020/1503").
- III. That the Platform has presented to users registered on its website a project through which investors have the opportunity to provide funding to IRIS, S.R.L. (the "**SPV**") to finance the proper execution and marketing of the Project, each of the Investors expresses their interest in participating by providing financing in the form of a loan to the SPV for an amount equivalent to their respective Committed Contribution, resulting in a potential return for each of the Investors through the payment of interest and the repayment of the aforementioned loan (the "**Loan**" and, together with those of the other investors, the "**Loans**").
- IV. To this end, each of the Investors hereby signs, in concert with the present agreement, via the Platform (as a website), a financing agreement with the Platform and the SPV, for the purpose, amongst others, of regulating the general terms and conditions applicable to the Loan granted by the Investor via the Platform in favour of the SPV, as well as to the Security – as defined below – and to grant the Platform an irrevocable mandate to carry out intermediation tasks via the Platform, in relation to the Loan, between the Agent, the payment institution, the SPV and the Principals (the "**Financing Agreement**").
- V. The granting of the loan by each investor, jointly with the other investors, shall be formalised by means of the relevant loan agreement signed in a private document between the investors, represented by the Platform, and the SPV (the "**Loan Agreement**"). The obligations undertaken by the SPV under that Loan Agreement (the "**Secured Obligations**") shall be secured by the following security (the "**Security**"):
  - First ranking mortgage on the assets of Iris S.r.l.
  - First-ranking pledge over all present and future bank accounts of the Borrower, including all credit

balances and proceeds thereon. It remains understood that the pledge will be enforced only in case of Borrower's gross breach to the loan agreement.

- Cost overrun guarantee from the Borrower, covering any shortfall in the total development costs required to complete the Project.
- Full cash sweep
- Maintenance of the Guarantees during the life of the loan and impossibility of granting the same or better guarantees in favour of other creditors.
- Subordination of corporate loans as well as any other loan to the Urbanitae loan.
- Irrevocable Mandate of Sale in favour of the Lender enabling the direct sale of the underlying asset of the project from a price floor equivalent to 75% of the last available appraised value on the effective date of the Mandate of Sale. The effective date of the Sale Mandate shall be called during the last 6 months of maturity. The details of the sale mandate will be further clarified and agreed upon by the parties as the transaction progresses to a more advanced stage.

It is considered essential for the Investors that the Secured Obligations are secured by the Security.

- VI. For its part, the Agent is an entity which is professionally and habitually engaged in the provision of fiduciary services in securities issues and similar matters, and which possesses the capacity, means and experience necessary to act as agent and representative for the purposes of the creation, maintenance, management, administration and, where applicable, enforcement of the Security securing the Secured Obligations.
- VII. That the Platform and the Agent have, prior to the date of this Mandate Agreement, entered into a Framework Agreement setting out the terms of the Agent's collaboration in relation to the acceptance, maintenance, management, administration and, where applicable, enforcement of the Security to be granted as a security of the Secured Obligations.
- VIII. That, on the basis of the foregoing, the Parties agree that the Agent shall act as an agent of the Principals for the purposes of the Agent constituting, managing, administering and, where appropriate, enforcing the Security acting in any case on behalf of the Principals, for which they agree to sign this Mandate Agreement in accordance with the following.

## CLAUSES

### 1. Definitions

Any term in the Mandate Agreement beginning with a capital letter that is not expressly defined herein shall have the meanings given to it in the Financing Agreement.

### 2. Purpose of the Mandate Agreement

The purpose of this Mandate Agreement is:

- (i) the granting by the Investors of a mandate (even when it involves acting with multi-representation, self-contracting or a conflict of interest) in favour of the Agent, also pursuant to Article 1703 of the Italian civil code, which empowers the Agent to act as agent (and *mandatario con rappresentanza*) of the Principals, carry out all the necessary actions for the purposes of the valid and effective constitution, conservation, proper management, administration and, where appropriate, enforcement of the Security, in its capacity as Agent, respectively;
- (ii) the designation and appointment of the Agent for the above purposes;
- (iii) the establishment of the rules that will govern the relationship of the Agent with the Principal and the procedure for the making of decisions and execution of instructions by the Agent; and
- (iv) the establishment of the rights and obligations of the Parties in relation to this Mandate Agreement.

### 3. Appointment of the Agent: acceptance of the appointment

- (a) Each Principal hereby appoints and empowers (even when it involves acting with multi-representation, self-contracting or a conflict of interest) the Agent, who accepts, to act as its agent (and *mandatario con rappresentanza*) also pursuant to article 1703 and following of the Italian Civil Code under or in connection

with this Agreement and the deeds or agreements relating to the creation of the Security (the "**Security Documents**").

- (b) Unless expressly provided to the contrary in any Security Documents to which the Agent is a party, the Agent declares that, to the extent permitted under applicable law, it holds the relevant Security as agent for the Principal on the terms contained in this Agreement and in the Security Documents.
- (c) Each of the Principals authorises the Agent (in its capacity as *mandatario con rappresentanza* of the Principals) on its behalf to:
  - (i) enter into the Security Documents expressed to be entered into by the Agent; and
  - (ii) perform the duties, obligations and responsibilities and to exercise the rights, powers, authorities and discretions specifically given to the Agent under or in connection with the Security Documents together with any other incidental rights, powers, authorities and discretions.
- (d) Without prejudice to paragraph (e) below, each Principal hereby:
  - (i) irrevocably appoints the Agent, who accepts, to be and act as its agent (*mandatario con rappresentanza*) and special attorney in fact (*procuratore speciale*) pursuant to articles 1388, 1703 and 1704 of the Italian civil code under and in connection with any Security created by the Italian law governed Security Documents and, therefore so that, acting in the name and on behalf of each Principal, but also in its own name and on its own interest, it takes all the actions that it considers proper or necessary as provided under this Agreement and in the Security Documents and, in order to negotiate, approve the terms and conditions of, amend, execute and perfect (including without limitation, exercise all rights, remedies and powers of the Principal thereunder for the relevant creation, perfection, maintenance, enforcement, cancellation and discharge) the security interests governed by Italian law granted by each security provider to secure SPV's obligations under any of the finance documents connected to the Loan and the other Principals' rights under the finance documents connected to the Loan governed by Italian law, the Agent being expressly authorised to act in the name and on behalf of the Principals in connection with the aforesaid documents pursuant to, and in case of occurrence of the events described in, articles 1394 and 1395 of the Italian civil code, and the Agent hereby accepts such appointment. The Principals expressly waive any right they may have under article 1394 of the Italian Civil Code in respect of contractual arrangements entered into by the Agent in their name and on their behalf pursuant to or in connection with the Security Documents, in each case to the extent legally possible to such Principal;
  - (ii) grants the Agent the power to negotiate and approve the terms and conditions of such Security Documents, execute any such Security Documents, execute any other agreement or instrument (including without limitation those necessary or appropriate to confirm, extend and/or amend the security interest created under the Italian law governed Security Documents), give or receive any notice or declaration, identify and specify to third parties the names of the Principals at any given date, and take any other action in relation to the creation, perfection, maintenance, enforcement and release of the security and other rights created thereunder, any amendments and/or waiver thereof which is made in accordance with this Agreement and the Security Documents and any other such agreement, instrument, notices or declaration, in each case in the name and on behalf of the Principals;
  - (iii) confirms that in the event that any security created under the Security Documents remains registered in the name of a Principal after it has ceased to be a Principal then the Agent shall remain empowered to execute a release of such security in its name and on its behalf;
  - (iv) undertakes to grant any power of attorney as it might be needed or appropriate for the Agent to act in accordance with and within the limits of this Agreement and the Security Documents;
  - (v) undertakes to ratify and approve any such action taken in the name and on behalf of the Principals by the Agent acting in its appointed capacity;
  - (vi) confirms that the Agent is entitled to release any Security Documents upon payment in full of any amounts due thereunder before the expiry of the applicable claw-back or ineffectiveness period, subject to satisfaction of the conditions set out in the Security Documents; and
  - (vii) undertakes to co-operate in good faith with the Agent in order to allow the latter to carry out the mandate granted under this Agreement.



- (e) The Agent may sign the Security Documents at different times without the requirement that the same are executed at the same time or in the same context.
- (f) Each Principal agrees that the Agent will be exempted from any reporting duty (*obbligo di rendiconto*) pursuant to article 1713 of the Italian civil code, save as in the case of its gross negligence (*colpa grave*) and wilful misconduct (*dolo*).
- (g) In acting in the capacity of *mandatario con rappresentanza*, also for the purposes of Article 1704 of the Italian civil code, pursuant to paragraph (d) above under this Agreement or any of the Italian law governed Security Documents (as applicable), the Agent shall be deemed to have all the rights, protections, immunities, authorisations, indemnities and benefits conferred on the Agent under and by this Agreement or any other Security Documents.
- (h) The Agent expressly undertakes to use its best efforts to perform the functions assigned to it in this Agreement in a prudent and diligent manner, always attending to the protection of the interests of the Investors in their capacity as Principals.
- (i) The Agent is not authorised to act on behalf of a Principal (without first obtaining that Principal's consent) in any legal or arbitration proceedings relating to any Security Documents, including any enforcement proceedings (*rappresentanza in sede esecutiva*).

#### 4. Obligations of the Agent

In relation to this Mandate Agreement, the Agent undertakes to:

- (i) To receive from the Platform the precise communications and instructions on any decision, action or authorisation that may have been adopted by the Investors in relation to the Security and to proceed with the execution of any instructions received as a result of such decisions, actions or authorisations, as soon as possible.
- (ii) Execute instructions received as a result of such decisions, actions or authorizations in relation to the Security.
- (iii) Accept and execute as agent (and *mandatario con rappresentanza*) of the Investors the Security Documents on the terms that the Investors consider appropriate.
- (iv) To carry out all the necessary actions for the proper constitution of the Security, as well as to grant, without delay, as many public and private documents for the correction, complement or clarification of the Security as may be necessary or convenient for this purpose.
- (v) To carry out all the necessary actions for the proper conservation of the Security in the registry when requested by Urbanitae, at the indication of the Principals.
- (vi) Inform the Platform of the steps taken and the status of the validity of the Security and any other incidents that may occur in relation to the Security throughout the life of the Loan.
- (vii) To exercise the actions for the execution of the Security within the precise period and terms indicated in the instructions issued by the Platform and in accordance with the provisions of the deed or policy of constitution of the aforementioned Security. For these purposes, the Agent may hire the law firm, the agency and/or the solicitors indicated by the Platform and any others that it deems appropriate for the correct execution of the Security, subject to the acceptance of the Investors through the Platform.
- (viii) To receive, from the Platform, and in the event of non-compliance with the SPV, the certification of the debit balance or amount due for the purposes of the proper initiation of the procedure for the execution of the Security; as well as to collaborate with the Platform and the selected law firm in the execution of the notarial deed of settlement of the debit balance, certification of ownership and charges and/or any other document or act necessary or convenient for the enforcement of the Security.
- (ix) To inform the Platform on an ongoing basis, so that it in turn keeps the Investors informed, of the status of the Security and of the amount of the net amount that may result from the enforcement of the Security so that the proceeds of the enforcement can be distributed among the Investors.
- (x) Carry out all the actions that are necessary for the due cancellation of the Security once the Agent has been duly notified by the Platform of full compliance with the secured obligations of the SPV under the Loan Agreement and connected finance documents and receives the appropriate instructions in this regard, if applicable.



- (xi) Perform all legal acts, sign any document, of any kind, whether public or private, that are necessary or convenient for the correct and punctual fulfilment of the functions entrusted to it by virtue of this Agreement.
- (xii) Receive from the Platform the list of Investors, without the Agent having to accept or authorize any type of change in the Investors.

The Agent assumes no responsibility for the authenticity, accuracy or correctness of the information that, by virtue of the provisions of this Agreement, is sent to it by the Platform or the Investors. Nor does it assume any liability arising from the Platform's failure to comply with any of its obligations in relation to the Loan and to the Investors.

The Agent is exonerated from any type of liability related to the Loan and the Security.

The Agent assumes no responsibility for the authenticity, accuracy or correctness of the information that, by virtue of the provisions of this Agreement, is sent to it by the Platform. Nor does it assume any liability arising from the Platform's failure to comply with any of its obligations in relation to the Loan and to the Investors, or for the integrity, validity and effectiveness of the Agent granted in relation to the Loan.

The Agent shall not be obliged to take any action in relation to the Loan (except for those related to the execution of the Security / Guarantee Agent described in this Agreement), but only in relation to the Agent following the instructions of the Platform for such purposes, in accordance with the decision of the Principals. The Agent may refrain from taking any action if the taking of such action, in its opinion based on reasoned legal interpretation, is contrary to any law or would not have the authority to do so under any applicable law or regulation or if any court or other competent authority determines that it does not have the authority to do so. The Agent will not be responsible, where appropriate, for the calculation, settlement or payment of the expenses and taxes corresponding to the constitution of the Agent, being the Principals who will be responsible in any case for any administrative requirement, payment of quota, interest and penalties that, where appropriate, impose the corresponding authorities for an incorrect calculation or defect of payment or payment after the deadline of the aforementioned tax.

In addition, the Investors shall not claim in any case from the Agent any expenses, costs or taxes that have been accrued or will accrue in the future as a result of the creation, maintenance, execution or cancellation of the Security, or in any other way in the exercise of the functions and responsibilities contained in this Agreement.

## **5. Obligations of the Principals**

The Principals, in relation to this Mandate Agreement and through the Platform, undertake to:

- (i) Provide the Agent, through the Platform, with the information they need in a timely manner, whenever such information is essential for the proper performance of their functions.
- (ii) Ensure that the SPV promptly pays the Agent its fees, costs and expenses for the performance of its duties as set forth in this Agreement.
- (iii) To keep the Agent duly informed, through the Platform and in accordance with the instructions received through it, of any circumstances that may have an impact on the Security.
- (iv) Ensure that the SPV duly complies with the obligations assumed in the Loan Agreement in relation to the proper conservation of the asset subject to the Agent.
- (v) To provide the Agent, through the Platform, with all the necessary documentation and to guarantee compliance with all the requirements necessary for the effective constitution, administration, cancellation and enforcement, where appropriate, of the Agent.
- (vi) Hold the Agent harmless for any expense, cost or tax that may be accrued in the exercise of the functions of representation of the Principals set out in this Agreement, as well as for any possible claim that may arise against the Agent regarding the integrity, validity and effectiveness of the Security.

## **6. Adoption of resolutions by the Investors**

Any instruction or decision taken by the Investors in relation to the Agent must be taken in accordance with the majorities and other circumstances set out in the Loan Agreement.

In the event that the Agent is required to seek authorisation from the Investors (which may only be granted by the relevant majority), it shall inform the Platform, which in turn shall forward the request to all Project Investors for the assessment of the request submitted.

Voting shall be open only to those natural or legal persons who, at the time of the decision, hold a percentage of the Loan (i.e. who are considered "Investors"), excluding any third-party assignee who has acquired a stake in one or more of the Loans through channels other than the Platform and who has not been notified to Urbanitae at least five (5) working days prior to the opening date of the vote.

The voting period shall last for five (5) working days (although it may be extended, at Urbanitae's discretion, to a maximum of fifteen (15) working days, either on its own initiative or at the request of the Agent), after which Urbanitae shall communicate, via the Platform, the results of the vote to the Agent and the Investors.

Once the Platform notifies the Agent of the adoption of an agreement by the Investors, the Agent must refrain from taking any action that may contravene such agreement, and must carry out any necessary action, where appropriate, to enable or promote its implementation.

The resolution adopted by the Investors and communicated by the Platform to the Agent shall be deemed binding in all respects on the Agent, as well as on all Investors.

#### **7. Application of proceeds from the enforcement of Security**

All sums received by the Agent as a result of the enforcement of the Security, and once any tax liabilities arising from their application have been met, shall be applied in accordance with the order of priority of payments set out below:

- (a) payment of the Agent's fees;
- (b) payment of the fees of notaries, solicitors, barristers, directors and other expenses that may have been incurred in connection with the enforcement of the Security, if applicable;
- (c) default interest on the loan;
- (d) ordinary interest on the loan; and
- (e) Outstanding principal payment for

Once all the aforementioned taxes and payments have been covered, any resulting surplus shall be returned to the SPV.

#### **8. No waiver by the Agent**

The Agent shall not waive its position as Agent granted and accepted under this Agreement, nor shall it waive the Security until the full cancellation or completion of enforcement proceedings.

#### **9. Fees and expenses of the Agent**

The Parties mutually acknowledge that no fees are payable to the Agent for the provision of services agreed between the Platform and the Agent.

That said, the Agent shall not be liable for any expenses or taxes that may arise from the performance of their duties, including, but not limited to: notary and agency fees, solicitors' and barristers' fees, property registration fees, stamp duty, etc., courier and registered post charges, travel expenses for attending signings, registrations, and accommodation in hotels outside the Agent's province of residence, etc., all of which must be reimbursed.

#### **10. Term of the Mandate Agreement**

The Agreement shall enter into force on the date of its signature by the Parties.

The term of the Agreement shall be extended either (i) until the Loan has been repaid in full by the SPV, in strict compliance with the obligations assumed under the Loan Agreement, and the consequent cancellation of the Security; or (ii) in the event of a breach of the Secured Obligations, until the completion of the procedure for the enforcement of the Security in the event that the Agent receives instructions to proceed with their enforcement.

#### 11. Cases of termination

This Agreement shall be terminated early, in addition to the cases specifically provided for in other Clauses, in the following cases:

- (i) At any time, by mutual written agreement between the Parties;
- (ii) Upon written notice given by either Party on the grounds of a material breach of any of the obligations assumed by the other Party under this Agreement, without prejudice to the aggrieved Party's right to elect to continue the Agreement and to require the other Party to perform its obligations in full, with compensation, in any event, for the damage caused by such breach where it is due to fault or gross negligence. In such a case, the non-compliant Party shall have a period of ten (10) calendar days to remedy the situation. If, following this period, in the opinion of the affected Party, the defaulting Party has not ceased its conduct or remedied the cause of its breach, the affected Party may terminate this Agreement with immediate effect, and the affected Party shall also be entitled to pursue any of the remedies provided for by law; and
- (iii) Due to the dissolution or liquidation of the Agent.

#### 12. Obligation to indemnify

The Platform, the Principals and the SPV shall indemnify and hold harmless and free from any costs or damages to the Agent, its partners and the individuals it appoints as representatives in respect of any claim, action, suit, damage, cost or loss arising (directly or indirectly) out of or in connection with the provision of its services under the Agreement; unless caused by fraud or gross negligence on the part of the Agent.

#### 13. Confidentiality

Unless required by law or a judicial authority, neither Party may, at any time, disclose, communicate or divulge to any person, or use, any information relating to the Agreement or the Guarantees (including the subject matter of such agreements) where such information is not generally known to the public at the time of its disclosure to the recipient (the "**Confidential Information**").

All of the foregoing is subject to the proviso that if a Party is required to disclose any Confidential Information by any applicable law or court order, or – specifically in the case of the Agent – when executing this Agreement, it must disclose any Confidential Information.

Except in the cases indicated above, Confidential Information may not be disclosed to third parties. The duty of confidentiality provided for in this clause shall apply, including in the event of termination, for a period of two (2) years from the effective date of termination.

#### 14. Protection of Personal Data

In accordance with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data ("**GDPR**") and its implementing regulations, the parties to this Agreement, on behalf of each of the Parties, by signing the Contract, expressly consent to their Personal Data being processed by the Parties as Data Controllers, for the purpose of the proper development and performance of

the relationships arising from or based on this Contract, as well as for the management and submission of documentation relating thereto.

The legal basis for the processing of the Personal Data of the parties involved is, therefore, the maintenance, fulfilment, development, monitoring and performance of the contractual and/or legal relationship arising from this Agreement.

Furthermore, the Personal Data provided shall be retained only for the time strictly necessary, for the sole purpose of ensuring compliance with any legal obligation which, under this law, may fall upon the Parties, and in any event, for the duration of the Contract.

The parties involved, in accordance with the terms set out in the GDPR and other related regulations, may in any case withdraw the consent granted for the processing of their Personal Data, as well as exercise their rights of access, rectification, erasure, objection and portability, being aware, by virtue of signing this Agreement, of their right to lodge a complaint with the relevant supervisory authority.

The parties may exercise the aforementioned rights by contacting the address of each party as set out in the header of this Agreement, sending a written request, attaching a photocopy of their National Identity Card or passport, and clearly marking the envelope "*Ref. Data Protection*".

## **15. Assignment**

The Principal Parties may assign, transfer, substitute or subrogate, in whole or in part, the rights and obligations assumed under this Agreement. Notwithstanding the foregoing, the validity of the assignment shall be subject to the registration of the new Investor on the Platform and to notification to the Agent, provided that the latter makes the appropriate amendments to the documents, both public and private, that have been granted in the performance of its obligations under this Agreement.

However, the Agent may not assign, transfer, substitute or subrogate, in whole or in part, the rights and obligations assumed under this Agreement without the express written consent of the Platform.

## **16. Miscellaneous**

### **16.1. Amendments**

The Platform shall inform the other Parties of any amendment to the contract that may arise as a result of changes in applicable regulations or for any other objective reason, or which the Platform deems appropriate or convenient.


Such amendments shall be deemed to have been accepted if the Parties do not express their objection in writing within 15 calendar days of notification.

It is also noted that the agreement adopted by the majority of investors as provided for in clause 6 above shall be binding on all of them.

### **16.2. Severability of clauses**

Should any provision of this Agreement be deemed void, illegal or unenforceable in any respect, the validity, legality or enforceability of the remaining provisions of this Agreement shall not be affected in any way or impaired by such provision. Subject to prior agreement with the Principal, the Agent undertakes to replace the provisions declared void or unenforceable with valid ones, the economic consequences of which are as close as possible to those of the provisions affected by the nullity, illegality or unenforceability. To this end, the Agent undertakes to amend this Agreement accordingly.

### **16.3. Actions and Non-Waiver**

The rights, powers and remedies set out in this Agreement are cumulative and are not, nor shall they be construed as, exclusive of any rights, powers or remedies provided for by law.

Under no circumstances shall the Investor's failure to exercise, or delay in exercising, any of the rights, powers and remedies provided for in this Agreement or by law constitute a waiver of this Agreement. Similarly, no single or partial waiver of such rights shall preclude the subsequent or separate exercise of such rights, nor the exercise of any other right.

#### **16.4. Notifications**

Any communication between the Agent and the Investors relating to the Agreement must be in writing, and the Agent must communicate it to the Platform, which in turn must communicate it to the Investor(s), and vice versa.

General communications relating to this Mandate and those which refer to it in their entirety, which must take place between the Principals and the Agent, and where applicable with the SPV, shall necessarily be channelled through the Platform, in accordance with the following provisions.

All requests, notifications and communications in general between the Platform and the Collateral Agent shall be made in writing through a designated representative of each party, to the postal addresses and/or email addresses provided for this purpose by each party.

#### **17. Electronic execution of the Agreement**

The Parties consent to the execution of the Contract by electronic means.


#### **18. Applicable law. Jurisdiction**

##### **18.1. Applicable law**

The Contract shall be governed by and construed in accordance with Spanish common law, without the application of conflict of laws rules.

##### **18.2. Jurisdiction**

The Parties, expressly waiving any other jurisdiction to which they may be entitled by law, hereby expressly submit to the jurisdiction of the courts and tribunals of the city of Madrid for the resolution of any dispute or claim that may arise in relation to the interpretation or performance of the Contract, including those relating to non-contractual obligations arising from or in connection with it.
