

WAGONEX PRIZE DRAW TERMS AND CONDITIONS.

The Promoter is: WAGONEX LTD (10312289) Registered office at Acre House 11-15 William Road, London NW1 3ER

How to enter this free prize draw:

1. All entrants to the prize draw must be aged 21 years or over. Resident of the UK.
2. Entries are automatically made by share the competition post and tagging two Facebook contacts.
3. The closing date for the competition is 3pm on Friday 29th March 2019.
4. All entries received after this time on the Closing Date are automatically disqualified.
5. Proof of submission is not proof of receipt. No responsibility can be accepted for entries incomplete, delayed, damaged, wrongly delivered or not received for whatever reason.
6. There will be one winner selected at random by Wagonex from all entries submitted before the closing date
7. By submitting an entry, you are agreeing to be bound by these terms and conditions.

Eligibility:

8. Employees and agents of Wagonex Limited and its associated companies, their immediate families or anyone professionally connected with this prize draw are excluded from entry. Only one entry per person, per household. Unless otherwise stated.
9. In entering this prize draw, you confirm you are eligible to do so. Wagonex may require you to provide evidence of your eligibility.
10. Wagonex will not accept entries that are completed by third parties, are in bulk, illegible, have been reconstructed, forged or are incomplete.
11. Wagonex reserves all rights to disqualify you if your conduct is contrary to the spirit of intention of the prize draw.

- The vehicle the customer wins may need to be switched and replaced with a similar vehicle. The vehicle will be the same engine size and trim level but some specification and options may change.
 - The vehicle must not exceed 5000 miles. It will be the customer responsibility to inform Wagonex if they are approaching mileage limit.

 - If required the swap of the vehicles will be booked 4 weeks in advance and the Wagonex team will be in contact to arrange the handover.
 - The vehicle will be covered by Wagonex supplied roadside assistance
 - The vehicle will be insured by Wagonex insurance
 - the Customer shall inform Wagonex insurance immediately by calling 0344 573 1229 between 8am and 5.15pm Monday to Friday, in the event that the Vehicle sustains damage or requires repair or maintenance during the Loan Period. The vehicle shall not be repaired without Wagonex's prior consent irrespective of whether Wagonex or the Customer insured the Vehicle.
 - The Vehicle will be provided by Wagonex in a clean condition with a quarter tank of fuel and must be returned Wagonex by the Customer in the same condition. Any costs incurred to clean and/or fuel the Vehicle after the return of the Vehicle will be charged to and are payable by the Customer.
 - The Vehicle must be returned free from any damage to the designated representative of Wagonex at the end of the Loan Period or on demand by Wagonex.
 - The Vehicle must not be taken out of the United Kingdom without the prior written consent from Wagonex.
 - Any motoring or traffic offences, congestion charges, other toll charges and resultant penalties and/or fines (together referred to as "Charges") arising in relation to the Vehicle from the date that the Vehicle is provided to the Customer until such time as the Vehicle is returned to Wagonex are the sole responsibility of the Customer. The Customer will indemnify Wagonex and reimburse the promotor forthwith upon demand for any Charges paid by Wagonex. The relevant parties (Police/Clerk to the Justices) will be informed by Wagonex as required.
 - Smoking is not allowed in the Vehicle.
 - The Customer shall not at any time disengage any active safety features of the Vehicle including but not limited to DSC (Dynamic Stability Control).
14. It is the winner's responsibility to fuel the vehicle, this is not included within this promotion.
