**ANNUAL MEMBERSHIP**  
**LIABILITY WAIVER AND RELEASE**

Broome Park Hotel

In consideration of the grant of permission to use the Fitness Centre and the exercise equipment provided in the Fitness Centre (the 'Equipment') provided by Broome Park Hotel, I hereby agree as follows:

1. I recognise and acknowledge that, because of the nature of physical exercise, I may sustain injuries because of my actions or failure to act; my failure to heed posted warnings; my use or misuse of the Equipment; or the actions or failure to act by other persons. **I HEREBY ASSUME ALL RISKS OF SUCH INJURIES AND WAIVE ANY CLAIM I MAY HAVE AGAINST BROOME PARK HOTEL AND ITS AFFILIATES AND THEIR RESPECTIVE OFFICERS, EMPLOYEES, AND AGENTS RELATED TO ANY SUCH INJURIES.**
2. I agree to familiarise myself with the proper use and operation of the Equipment before I attempt to use it and to read and abide by all posted notices, warnings and rules related to its use. I further agree, before each use, to examine the Equipment to satisfy myself that it is in proper operating condition and to promptly report any problems with the Equipment to Broome Park Hotel.
3. I acknowledge that Broome Park Hotel strongly recommends that I consult with a physician before I undertake any physical exercise program using the Equipment or otherwise. If any injury to me results from my use of the Equipment and my spouse, companion or parent cannot be notified, I hereby give my authorisation to any attending physician or emergency medical personnel to render such treatment as would be normal and necessary under the circumstances and I agree to pay the usual and necessary charges for such treatment.
4. I agree, on behalf of myself and my heirs, administrators and personal representative, to indemnify, hold harmless, and defend the Released Parties from and against any loss, liability, claim or damage. I may incur that is a result of my access to the Fitness Centre or my use of the Equipment, including without limitation solicitors' fees.
5. I assume full responsibility and agree to pay for any and all damage to the Equipment that resulted from my use of it where such use is due to my negligence or wilful damage as well as any damage to the property of third parties related thereto, including all solicitors' fees, expenses, and court costs related thereto.
6. No person who has not read and signed this Agreement is authorised to enter the Fitness Centre or to use any of the Equipment. I agree that I will not allow any such unauthorised person to

accompany me with a view to securing access to the Fitness Centre or the Equipment. I assume full responsibility for any guest whom I allow to enter the Fitness centre or use any of the Equipment in violation of this provision.

7. I certify that I am 18 years of age or older and agree to supervise my child/ward at all times while using the equipment in the Fitness Centre.

10. **I/MY CHILD/WARD HEREBY WAIVE AND RELEASE BROOME PARK HOTEL AND ITS AFFILIATES, SHAREHOLDERS, SUBSIDIARIES, OFFICERS, DIRECTORS, EMPLOYEES, AND AGENTS (THE "RELEASED PARTIES") FROM ALL CLAIMS OF ANY NATURE THAT MAY BE FILED BY OR ON BEHALF OF ME/MY CHILD/WARD OR ANY OTHER PERSON, AND ANY LIABILITIES RELATED THERETO, THAT ARISE OUT OF MY CHILD/MY WARD USE OR OPERATION OF THE EQUIPMENT, INCLUDING WITHOUT LIMITATION ANY CLAIM FOR PHYSICAL OR MENTAL INJURY OR FOR DAMAGE TO OR LOSS OF ANY PERSONAL PROPERTY, UNLESS CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF A RELEASED PARTY, AND ALL SOLICITORS' FEES, EXPENSES AND COURT COSTS RELATED THERETO. ## **BROOME PARK LEISURE MEMBERSHIP RULES AND REGULATIONS**

### **TERMS AND CONDITIONS OF LEISURE MEMBERSHIP**

- The premises of Broome Park are owned by Kitchener Hotels Ltd
- The Management will allow the use of the premises and the facilities by persons who apply to become and are granted leisure membership in accordance with the terms and conditions set out in this document.

### **LEISURE MEMBERSHIP FEES**

- Applicants for Leisure Membership are required to:
- Complete, sign and present an application form (note that each adult applicant must sign the form).
- Pay the appropriate fee applicable at the time and for the duration of the required membership.
- Provide 2 passport size photographs per applicant to provide Leisure Membership card/s.
- By signing the application form an applicant warrants and guarantees that the information in the application form is correct.
- The management may apply different rates of monthly subscriptions to different categories of Leisure Memberships and may vary or amend such rates for new applicants for Leisure Membership at any time at its complete discretion.
- Admission to Leisure Members is at the complete discretion of the management, who is not bound to give any reason for refusing an application.
- If an application is refused; all monies paid will be refunded on a pro-rata basis.
- An application form for any form of joint Leisure Membership will only be acceptable if 2 persons named in it are resident at the same address. Evidence of this may be required. Individual adults who sign the application for any such form of Leisure Membership will be jointly and severally bound by these terms. Responsibility for all, subscriptions and payments will be with the primary Leisure Member.

### **LEISURE MEMBERSHIP CARDS**

- Each new Leisure Member will be provided with a Leisure Membership card, which will remain the property of Broome Park and on termination will be returnable.
- Leisure Members must present their membership card to reception on each visit before using the facilities. Failure to present a card may incur an entry fee. The loss of a card must be reported immediately. There is an administration charge of £10.00 for a replacement card or for the change of a membership name holder.

### **CHANGE OF ADDRESS**

- Leisure Members shall inform the management of any changes in the information given on the application for membership form (e.g. address, telephone number, bank details).

#### **TERMINATION**

- In the case of a Leisure Membership being terminated, it shall be at the sole discretion of the management as to whether any membership fee is refundable.
- Leisure Membership shall be terminated:
  - The Leisure Member giving one month's notice to the management in writing.
  - Automatically, if the Leisure Membership subscription is not paid by the end of the month in which it falls due.
  - By the Management with immediate effect.
- The Management will not be bound to give any reason for terminating the Leisure Membership and is not obliged to make any refund of any fee or subscription paid to the date of termination.

#### **AVAILABILITY OF FACILITIES**

- Leisure Memberships will be granted at the discretion of the Management and members will be required to show their cards on each visit
- Leisure Membership will not be transferable and the Management reserves the right to refuse applications and renewals of Leisure Membership without notice and without giving reasons for doing so.
- The Management may stipulate terms and conditions for the use of the premises and the facilities and these may include a requirement for the additional payments for special facilities and a prior booking system
- The Management shall determine the normal opening hours from time to time and determine the hours which are deemed to be peak and non-peak access times. The Management may alter these opening times, prescribe the time of the last entrance, or temporarily suspend the use of facilities (in part or full) or temporarily close the premises for repair, maintenance, cleaning or any other reason. No refund or reduction of fee or subscription will be made by reason of any such alteration, imposition, suspension or closure.
- The Management reserves the right to alter the rules, fees, Leisure Membership tariffs, and available facilities at any time and for any reason.
- At the Management's discretion, Leisure Members may bring guests into the premises up to the maximum determined by the external membership category. Guests must be accompanied at all times by the member and will be subject to separate charges. The guest will fall under the same terms and conditions where applicable and may be required to pre-book.

#### **USE OF THE FITNESS EQUIPMENT**

The management accepts no liability for any illness or injury resulting from the use of any facilities however that may have been caused. All people using the facilities do so on the understanding that it is at their own risk and Leisure Members and guests are advised to seek medical advice before undertaking any exercise.

Leisure Members are required to acknowledge that the equipment and facilities could be hazardous if not used in a proper manner or if their use is inappropriate to the characteristics and state of health or fitness of the user.

Leisure Members will observe any guidance on the use of the facilities given by the Management or staff.

Where the Management is satisfied that a Leisure Member has not observed the guidance given to them in the proper use of any item of the facilities the Management may:

- a. Suspend the Leisure Membership rights for a period not exceeding one month (without any refund of subscription) and
- b. Require the Leisure Member to have a further repeat induction programme (and charge a fee for the same) as a condition of retaining the membership.

### **SWIMMING POOL**

- Leisure Members using the pool will be subject to the rules and conditions of use appropriate to all users, which are available on the poolside.
- Children under 16 years of age must always be supervised by a responsible adult when using the pool.
- Children under the age of 8 years must always be accompanied in the water by a responsible adult, who can supervise up to three children.
- If swimmers are suffering from Athlete's foot or Verrucas, we would request that a recognised swim sock is worn.
- All babies and small children using the swimming pool must wear disposable swim nappies/trainer pants.
- Lifesaving equipment is not a toy, and should not be used as such. It is for safety use only and must not be removed/used, other than for lifesaving.
- Always shower before using the pool. There is a shower facility provided on poolside.
- Please note the pool timetable for off peak access, adult only swimming times, Aqua classes, children's Fun in the Pool and other swimming sessions as determined by the Management,

### **SPA, SAUNA AND STEAM ROOM**

- Leisure Members using the spa will be subject to the rules and conditions of use appropriate to all users, which are available poolside.
- Children under the age of 16 are not permitted to use the spa, sauna or steam room
- You should not use the spa if you are:
  - a. Pregnant
  - b. Suffer from heart disease or circulatory problems or high or low blood pressure or any condition that may affect your reaction to heat.
  - c. Are suffering from infectious skin diseases sores or wounds.
  - d. Are taking any medication or suffer from any condition, which makes you unsure as to the advisability of using the spa.

- e. That makes you unsure as to the advisability of using the spa.
- f. Have had a heavy meal or alcohol in the preceding one and a half hours.
- g. Children under the age of 16 years are not permitted use of the spa.

**GENERAL RULES AND BEHAVIOUR**

- The Management may from time to time introduce, amend and revoke rules and codes of behaviour (including dress code), which will apply to all Leisure Members.
- If the Management considers that any Leisure Members conduct either inside or outside the club premises is contrary to the interests of the club and its reputation it may expel or suspend such Leisure Member and will not be bound to give any reason for terminating the membership and shall not make any refund of any fee or subscription paid to the date of termination.
- Both expulsion and suspension will involve the Leisure Member’s immediate exclusion from the premises.
