### WHO CAN ENTER?

5. The person you nominate to win:

- a) must be aged 18 or over;
- b) must be currently employed as a key worker (listed by the UK government - <https://www.gov.uk/government/publications/coronavirus-covid-19-maintaining-educational-provision/guidance-for-schools-colleges-and-local-authorities-on-maintaining-educational-provision>) and is able to prove this by providing employment details to [hotel@tregenna-castle.co.uk](mailto:hotel@tregenna-castle.co.uk)
- c) must live in the UK and the Republic of Ireland; and
- d) must not be employees of any company associated with the Competition or their respective associated companies or agents, or family members including parents, partners or children.

### HOW TO ENTER

6. To enter the Competition, you must do the following between the Opening Date and Closing Date:

### PRIZES AND WINNER SELECTION

9. There will be one winner of the Competition (the “Winner”).

### PRIZE

10. The Winner will receive a 2 night hotel stay for 2 people. The prize will include breakfast both mornings, a 3 course dinner excluding drinks on one night, x2 60 minute relaxation treatments (must be pre-booked prior to stay) and 10% off any additional food and drink purchased during the stay. (together the “Prize”).

11. The prize must be booked and taken before 4th May 2021 and excludes public holidays and 23rd December 2020 – 3rd January 2021. The exact dates for travel shall remain subject to availability at the time of booking. No alternative dates will be available. All elements of the Prize must be taken together.

spending money, travel, and any additional meals, drinks, tips, gratuities and any incidental expenses) are included.

a) a Winner does not comply with these Terms or Facebook's rules or Tregenna Castle Resort has reasonable grounds for believing that a Winner has broken a rule contained in these Terms; or

b) a Winner does not (i) agree to these Terms or Facebook's rules; (ii) want to receive the Prize; or (iii) give any consent as may be requested by Tregenna Castle Resort within 24 hours; or

c) Tregenna Castle Resort cannot contact a Winner or a Winner does not respond to any requests from Tregenna Castle Resort for information (e.g. confirmation of their address and proof of employment) within 48 hours of such request.

## GENERAL

Tregenna Castle Resort reserves the right to cancel this Competition at any stage prior to the Opening Date or to shorten the time for entering the Competition on notice, if Tregenna Castle Resort thinks it is unavoidable, or if circumstances arise which are out of Tregenna Castle Resorts control.
